

Dear Participant,

Great news! Horseback riding will be available at Camp Fairlee through the Kent Association for Riding Therapy (KART) for all **COVID19 vaccinated campers**. The cost of this activity is **\$60.00** for 2 one-hour lessons and transportation to and from the riding program.

The program is held at Worthmore Farms, a riding center accredited by the Professional Association of Therapeutic Horsemanship (PATH). Instruction is provided under the direction of a PATH certified therapeutic riding instructor. All riders use a leader and side walkers.

The KART staff will visit Camp Fairlee on the Monday evening of each session to evaluate participants and their ability to ride. If it is found to not be in the best interest of the participant to ride, a full refund is issued. The riding sessions are held on Wednesday and Thursday mornings 10:30-11:30 for the six-day session and Tuesday and Wednesday for the twelve-day session.


Participants need to bring long pants-trousers and closed toed shoes or boots to wear to riding.
