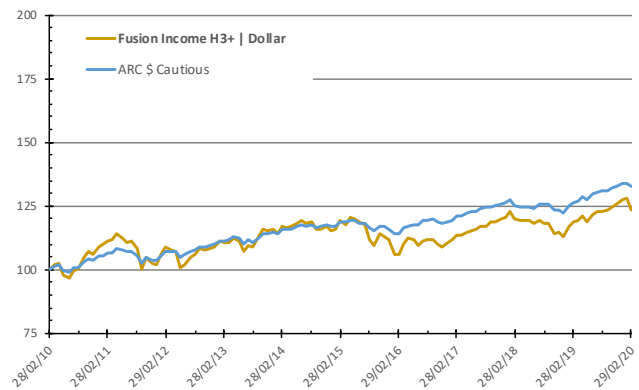

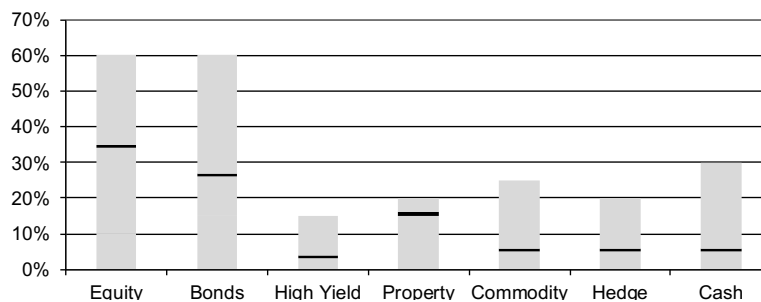

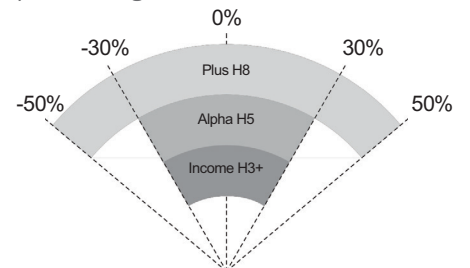

## Investment Commentary

In the first two weeks of February, markets were able to shrug off concerns regarding the COVID-19 outbreak in China and were supported by better than expected US Q4 quarter earnings. However, a spate of outbreaks in Korea, Iran, Italy and the US raised concerns that the global economy may experience further shutdowns in travel and production.

While significant downside risks cannot be ignored, they are likely to be contained to an extent by the central bank 'put'. The Federal Reserve has cut rates by 50bps and central banks have confirmed they will take whatever action necessary to support the financial system. We may potentially see further quantitative easing over the coming weeks which could provide support to markets.

Whilst performance has been negative in February, we are monitoring developments continuously and will take such actions as we feel necessary to either protect investment portfolios or to take advantage of short term market weakness to build positions.

## Strategy Overview

In pursuit of attractive targeted returns, Fusion invests in a broad range of asset classes designed to maximise its ability to deliver returns whilst minimising the associated risk.

The Fusion Strategies are constructed around a managed portfolio of collective investment schemes, delivering a unique combination of diversification, flexibility and efficiency.

Fusion Income H3+ Strategy focuses on lower risk asset classes in order to achieve its return targets.

Investment exposure is weighted to lower risk asset classes such as fixed interest, arbitrage strategies and commercial property; the strategy includes some exposure to equities and other higher risk investments.

Targets a strategic currency exposure of 89% in the portfolio base currency.

Three and a half year rolling investment horizon and as a result focuses on lower risk asset classes whilst accepting lower returns.
