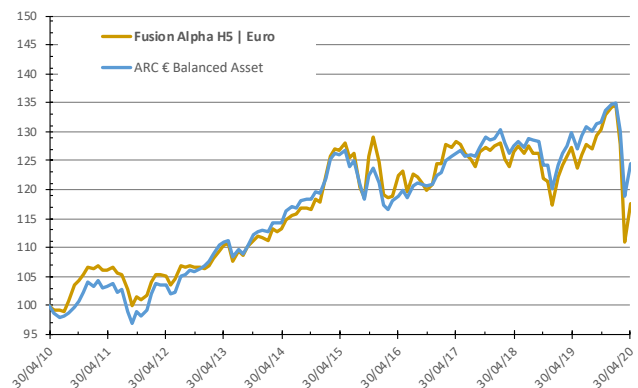

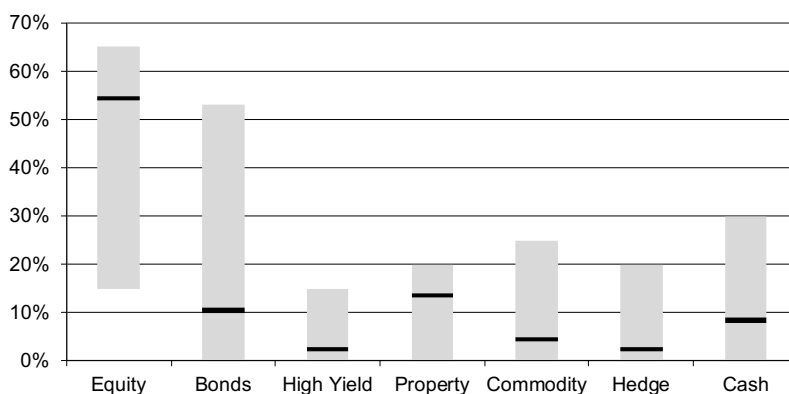

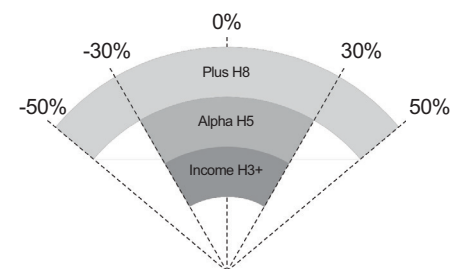


Asset Allocation

Investment Commentary

After the severe falls seen in March, markets rebounded as the peak of the pandemic was reached. Governments continued to respond with massive global fiscal and monetary measures which supported markets.

The US economy contracted by 4.8% on an annual basis in Q1 and jobless claims increased by 30 million over a six week period. However, stronger than expected first quarter earnings from the mega caps contributed to increased risk appetite. Oil markets were very weak, but Technology stocks continue to show resilience.

Fusion portfolios significantly outperformed the ARC benchmark in April; this reflected positive contributions from our worldwide diversified equity exposure.

The World is now focusing on how to exit the lock-down and restart their economies.

Strategy Overview
