# **Privacy Policy**

This Privacy Policy ("Policy") applies to https://www.crispcustoms.co/, and Crisp Customs ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include https://www.crispcustoms.co/. The Company's website is a Hand-Built And Customized High Performing Off Road, Sand, And Street Vehicles site. By using the Company website, you consent to the data practices described in this statement.

#### **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- -First and last name
- -Mailing address
- -Email address
- -Messages

The Company may also collect anonymous demographic information, which is not unique to you, such as your:

- -Age
- -Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. The Company may also use your personally identifiable information to inform you of other products or services available from the Company and its affiliates.

# **Sharing Information with Third Parties**

The Company does not sell, rent, or lease its customer lists to third parties.

The Company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to the Company, and they are required to maintain the confidentiality of your information.

# **Tracking User Behavior**

#### **Automatically Collected Information**

The Company may automatically collect information about your computer hardware and software. #### **Use of Cookies**

# **Right to Deletion**

- -Comply with an existing legal obligation; or
- -Otherwise use your personal information, internally, in a lawful manner that is compatible wi
