Executive Committee Chair Report: Alyssa Adwell

- Disability Justice Training has been postponed, will update at a later date –ACTION
- Added the discussion of the Community Activity Log to "New Business"
- Membership update
 - Three applications for the council so far
 - Open Positions:
 - Tribal VR Director
 - Ex-Officio
 - 4 Council seats
 - Applications to be reviewed and vetted in May/June by EC and voted by the council in July
 - Mona will re-word our recruitment blurb ACTION
 - WASILC staff will send a recruitment blast with the new blurb –ACTION

Executive Director Update: Kim Conner

- Final confirmation that FFY21 PR Report was approved
- Working with DOH and Kimberly Meck to provide input on disability questions on the Health Youth Survey (HYS) which is sent to middle students to high students annually
- Kim was Governor appointed to the Rate Setting Board which sets the rates for PA's through ought the state
- Kim appointed to NCIL Board as the Secretary

Youth and Young Adult Committee: Alyssa Adwell

- New chair: Naomi Marteeny
- Currently recruiting for new members with emphasis on BIPOC
 - Three new applicants being reviewed by EC
- Will review charter and discuss new projects after meeting the membership goal

Legislative Committee: Dion Graham

New member appointed, Experience in advocacy. Leadership, equity training and financial literacy

- Bringing people in to discuss the committee's efforts in advocacy
 - In conversation with a contact at American Veterans in West Seattle
- Will partner with the SPIL Committee on the Legislative Advocacy project

SPIL Committee: Kimberly Meck

• SPIL Survey sent out multiple times to networks, website, and social media

- As of April 5th there are 211 responses to the English survey and 4 responses to the Spanish survey
- Flyer in English and Spanish with QR Code and links to access the survey
- Community Forum: continue to work on for this summer. Encourage council members to participate
- CIL Consumer Satisfaction Survey being worked on by all CIL Directors for a uniform survey that every CIL will use to have some consolidated data and be able to show the effect of centers statewide
- SPIL Monitoring
 - o CILs have been very active in working on the SPIL goals

CIEP: Jim House

- Cascadia Rising '22 will take place in July
 - This is a state and regional exercise lead by Division of Emergency Management
- CIEP Tabletop Discussion on how CIEP <u>stands up</u> when there's a disaster being held on June 22nd. This is a CIEP exercise provided by a technical assistance opportunity by FEMA
 - General Protocols for CIEP Stand-Up_currently being reviewed to look for improvement in different scenarios

Ad Hoc - WASILC Statewide Community Needs Assessment: Kim

- Started process of developing outreach and membership for the committee
 - o Two new committee members
 - 5 new applicants for review
- Committee will focus on finding a consultant company for the community needs assessment once the membership goal has been reached
 - Focus on Women and BIPOC owned organizations as a priority

DSB Report: Tricia Eyerly

- Started a Technology Program
 - o Devices are loaned out with no expectation on getting them back
 - CCTV's, IPhones, IPads, magnifiers, etc.
 - Partnered with Washington Talk Book and Braille Library in Seattle to help administer the programs
 - Warehousing and distribution of the equipment
 - Program is getting great reviews and looking into ordering more tech for the program
 - Looking at how to support DSB's providers in the community to support that technology
- Looking into bringing more providers in for more coverage in the state
 - Specific focus on rural areas
- Center in the Tri-Cities area is closed
 - Sheila Turner covering the Central WA area through the Walla Walla Central WA area independently with a contract through DSB
- RSA Audit went really well

WATAP: Kimberly Meck

- Report review highlights to pay attention to
 - Funding
 - o Biden's Build Back Better

WSRC: Dion Graham

- Listening sessions with clients who receive services in specific areas
 - Last focus was in Spokane
 - o Focus on DVR Region 3 & Central Unit (Kelso, Centralia & Aberdeen)
 - In addition to subcommittee reports, we will provide a summary of the Listening Sessions we conducted in partnership with the Special Education Advisory Council (SEAC) with youth participating in Pre-Employment Transition Services.
- DVR State Plan Progress update is complete and available on the DVR website

- Work on the DVR Comprehensive Statewide Needs Assessment planning is in progress. We are expecting completion late 2022/early 2023.
- Next quarterly meeting will be held virtually on:
 - o May 12th & 13th from 9am noon

GCDE: Elizabeth Gordon

- Continued work on House Bill #1802, Nothing About Us Without Us, for submission next legislative session
 - Led by Disability Rights of Washington and a self-advocate who developed the idea and brought it to legislature
- Youth Leadership Forum held August 7th 12th at Dumas Bay Center in Federal Way
 - Link: https://esd.wa.gov/GCDE/projects#ylf
 - Six day, on-site camp for youth with disabilities to grow their leadership skills and grow their identity as people with disabilities
 - Free for youth
 - Held in Federal Way
 - GCDE will pay for youth travel costs
- Outreach Event in Colville
 - Listening sessions for people with disabilities to learn of any barriers in the community that can be solved/worked on
 - o Data is collected from listening sessions and discussed the following day
- Town Hall for people with disabilities on April 21st from 5:30p-7:30p
 - Virtual event
 - Outreach to community members to smooth partnership
- The Federal Government has released 95 different diversity and inclusion plans across federal agencies to discuss how to engage people who have been furthest from their services
 - Elizabeth was invited to a listening session with the White House through Federal programs to understand why people with disabilities were having difficulty with access
 - GCDE's focus on plans with Social security and voters access

Center For Independence: Todd Holloway on behalf of Leah Velasco

- Trying to increase outreach
 - o DOH meeting on 04.14.22 will help with that outreach work
 - Connecting with the Marysville office for concentrated outreach efforts
- Work on the AFN group

- Work with the Accessible Communities Advisory Council out of the governor's committee on employment disability or disability employment has expanded to get more counties involved
- Success with the feasibility study around the Wheel Care Accessible Taxi Program in Pierce County
 - Heavily involved with some transportation advisory groups
- Youth Transition Summer Workshop
 - Deadline for registration in mid-June
 - Hybrid set-up with a limited amount of people in person
- Increased Veterans contract with veterans who experienced traumatic brain injury, spinal cord injuries or any other neurologic disabilities
- Pathways to Community Living (PCL)
 - Expanding into North County
 - Work around deinstitutionalization
- The CDC expansion for different grants and funding that are coming in are working and expect to see funding continue on through the recovery process

Disability Action Center and INDEx: Mark Leeper

- Partnered with the Spectrum Center in Spokane to hold a vaccination clinic
 - Planning more for the future
- INDEx staff recruitment is slow
 - Challenged with affordable living in Spokane
 - New Youth Transition Coordinator with the Part B funds
- Working on a webpage and outreach
- 5K Mental Health Walk
 - Served both sides of the border, Idaho and WA
- Blue-Path.org is being revamped moving to a new platform
 - Directory of business accessibility/Business and Service accessibility

Central Washington Disability Resource: Mayra Colazo

- Attended PIDS Conference
- In partnership with DOH, discussing people with disabilities, minority groups, and work around alternative formats for sharing information (ASL, Braille, etc.)
- B.A. contract for surveys
 - No referrals yet
- Vaccine Clinics
 - 5 vaccine clinics
 - Kittatas, Chelan, and Grant
 - Total of 281 people vaccinated so far

- Used the unrestricted \$25K grant from Seattle Foundation to give \$50 cash incentives for vaccinations
- CARES funding
 - O Down to approx. \$40K for the rest of fiscal year

Alliance for people with disabilities- Kimberly Meck

- New name: Disability Empowerment Center
 - Rebranding and marketing work
 - Advertising in King County to talk about the center and what it does
 - Launch party in June/July
 - New landlords at the Auburn office who also runs "Your Money Matters" and a Youth Financial Literacy Program (serving ages 16-24)
 - Opportunity for access to more youth for disability awareness and trainings
- Vaccine Hesitancy work
 - Using the CDC funding received to fund five different organizations who are working on projects to address vaccine hesitancy within the disability community
 - Emphasis on Hispanic Latino populations, Asian Pacific Islander populations,
 Deaf and Hard of Hearing and LGBTQ+ populations
- Working on joining the team planning for the new county Equity and Social Justice Strategic plan
 - The plan is what the county uses in terms of its programming, missions, strategies, etc.
 - In the past the focus has been on the race of individuals, where they are located within King County, and how they have access to health related matters
 - Alliance is working with the county on redoing the report to include information regarding how disability impacts all determinants of equity
- Partnering with Seattle King County Public Health
 - Received CDC funding to do evaluations and surveys to get more information on the impacts of COVID in various populations within King County
 - Alliance is surveying 50 individuals with disabilities within King County to get lived experience and firsthand information

New Business

- July Quarterly Meeting Dates: Discussion and agreed to keep in-person dates
 - o July 14 & 15 in Seattle
- October Quarterly Meeting Dates
 - o Currently October 27th & 28th
 - Will vote on a date at the July QM

- Kim will send out an email to ask when people are available, those dates will be voted on in July –ACTION
 - Options: 7th & 8th or 20th & 21st
- NCIL Conference: July 25th-28th, Washington DC
 - Hybrid model
 - Conference workshops will be recorded and posted on the website within 30 days
 - August 1st-3rd will be the virtual workshops only
 - Theme: Forging Justice
 - Workshops will be recorded and some in-person events will be streamed
 - o Kim will send an email out for interested members who want to attend ACTION

Member Committee Community Log Review

 - Log activities done outside of council work like outreach efforts, technical assistance, public education, etc.
 - Could be as simple as bringing awareness to a neighbor on disability
 - o Information is collected and then used in the PPR report

Executive Director Transition

- Transition group needs to be formed led by the EC Chair
- Timeline: 3 months
- Will discuss a relocation budget with DVR –ACTION
- Kimberly will act as a liaison between the Transition Committee and the CIL Directors to be sure CIL input is brought forward
- Staff will convene first meeting –ACTION

<u>Motion:</u> Create a Transition Committee made up of Alyssa, Mona, and Kimberly with Alyssa having the ability to appoint additional members as she sees appropriate to lead to completion the process of selecting a new ED.
