#### MEDICAL

Again, even though we did not get to a situation of playing matches, many of our Trainers had completed their courses and were already providing support on training days and at practice matches. The culture of safety first at our Club led by Karen Bennett is an unbreakable pact we abide by. No trainer, no play. It is as simple as that. Personally, I will be forever grateful for this commitment to the safety and well being of our Club members.

#### FINANCE AND ADMINISTRATION

An enormous debt of gratitude must be given to our Treasurer, Garrick Rollason for his counsel and guidance throughout 2020. Our Club was faced with a challenge none of us thought we would ever face in not being able to deliver a football season to our members. We must also acknowledge previous administrations in leaving the Club in a strong position financially that enabled us to continue as an ongoing concern given many of our normal revenue streams were denied to us this season.



Given we were not able to commence a normal or abridged season, the Club refunded 70% of the member registration fee. In coming to this decision, we considered the costs already incurred for season 2020 while protecting the cash reserves of the Club.

That said, many of our members saw fit to donate their membership fee to the Club. This generosity has provided our Club with over \$20,000 that will be used for equipment purchases for many years to come.

Our Team Managers did an enormous job, marshalling the volunteers in each team in a tricky environment where the normal face to face conversations were not able to take place. Well done.

Remarkably our merchandise and apparel sales held up reasonably well given the uncertainty of the year. A lot of gratitude to Karen Bennett and Kendra Van Dame for the hours spent in front of the storage room. Kudos to them for suggesting to many parents to upsize the shorts or hoody just in case the items could not be used this year and could be used next year.

We were looking forward to working closely with our new canteen partner, Anne Patterson from 'Nourish'. We look forward to working with her team next year.

Thank to all parents and Club officials for their commitment to meeting our compliance requirements. It has become a heavy burden in recent years, so it is appreciated when people meet their compliance obligations.

## TREASURER'S REPORT



The 2020 football season has presented East Brighton Vampires Junior Football Club (the "Club") with a number of unique financial challenges, consistent with those faced across our community.

The financial year commenced with the Committee announcing reductions to our early bird registrations fees to below \$300 for the first registration in a family and with further discounts for multiple registrations within a family. As a result, the Club had a large number of members register up until the end of January. The Club collected nearly \$250,000 in registration fees for the season, prior to the payment of refunds.

As COVID-19 restriction were introduced by the State and Federal Governments, the Club actively tried to balance the requirements of preparing for the start of the season while minimizing costs. The importance of cost controls became more importance as a shortened or cancelled season became a likely outcome.

When the decision to cancel the season was announced by the League, the Club made the decision to provide a partial refund to all members. The key objectives in coming to the level of refund provided were to maximizing refunds to families while ensuring the financial viability of the Club in to the future. The Club entered the season in a strong financial position and this enabled the Club to provide all members with a 70% refund in their registration fees. The Club also had the objective to, where possible, deliver 'in season' refunds to members and after considerable time spent on the required logistics, this was achieved.

I would like to thank the Committee for their support through this process, the time spent on trying to balance our objectives led to what I believe to be the best possible outcome for our members and the Club.

The Club's cash position ended the year at close to \$100,000 ensuring the Club is well positioned for the future.

Many of the costs incurred early in the 2020 season will be able to deliver cost reductions in the 2021 season, enabling the Club to continue to deliver low registration fees for members, including significant discounts for families with multiple children.

The financial strength of the Club is in a large part the result of the strong financial support we receive from our Sponsors. In 2020, despite not playing any competitive football, the Clubs sponsors contributed close to \$22,000 to our Club. A special thanks to our Major Sponsor - Buxton Real Estate Agents Brighton and our silver sponsors Urbanedge Homes and Bendigo Bank – Elwood Branch.

The 2020 Financial Statements have been prepared by the Club and audited independently. These are available to all Club Members on the Club website.
