

# New Zealand Medical Journal (NZMJ) Subscription Information

Subscriptions to the *New Zealand Medical Journal (NZMJ)* are available to institutions, medical practitioners living outside New Zealand, and individuals who are not medical practitioners. Direct subscriptions are not available to New Zealand medical practitioners, who receive the *NZMJ* as part of their New Zealand Medical Association membership (NZMA).

Access to the latest issues of the *NZMJ* is generally available by login and password, and IP access is also available to some subscribers (see Conditions for Subscriber Access on reverse).

#### Conditions for Subscriber Access to the New Zealand Medical Journal

Since July 2002 the New Zealand Medical Journal has been an online journal. It can be found at: <a href="https://www.nzma.org.nz/journal">www.nzma.org.nz/journal</a>. To protect the value of the journal for NZMA members, as well as facilitating access for subscribers, the New Zealand Medical Association (the publisher) has a four-tiered system of subscriber access.

## Categories of subscriber

#### (i) International

Access is by username and password. IP access is also available on the payment of a set-up fee of NZ\$125 (in addition to the annual subscription). Subscribing institutions have the right to put the *NZMJ* on their intranet. Subscribers may print off a paper copy of the *NZMJ* according to their number of subscriptions (ie one subscription equals one paper copy). Note: if the international subscriber has users in New Zealand, then Category 2 or 3 or 4 will apply.

### (ii) New Zealand institution with a high proportion of medical practitioners

This category includes, but is not limited to, District Health Boards and medical schools. Access is by username and password. Subscribers are permitted to provide usernames and password access to individual users *on request*. Subscribers may print off a paper copy of the NZMJ according to their number of subscriptions (ie, one subscription equals one paper copy).

## (iii) New Zealand medical organisations (such as medical colleges)

Access is by username and password and is limited to National Office staff and two elected representatives. Subscribers are not permitted to provide usernames and password access to their doctor members, but may provide them with individual articles. Subscribers may print off a paper copy of the NZMJ according to their number of subscriptions (ie one subscription equals one paper copy).

#### (iv) Other New Zealand institution or subscribers

Access is by username and password. IP access is available (on request) on the payment of a set-up fee of NZ\$125 (in addition to the annual subscription). Subscribing institutions may request to put the NZMJ on their intranet. Subscribers may print off a paper copy of the NZMJ according to their number of subscriptions (ie, one subscription equals one paper copy).

Payment of the subscription fee implies acceptance of these conditions. Usernames and passwords will be supplied when payment is received. Subscription to the NZMJ is for a calendar year. Individual subscription is not available to medical practitioners who practise in New Zealand (NZMA membership is available in this case).

## **Additional information**

- We will assume that subscribers wish to continue their subscription each year, and they will be invoiced accordingly; unless we hear otherwise.

- We need an email address and contact name for each subscriber. Please notify us of any changes, as email alerts are sent out when each new issue of the NZMJ goes online.
- NZMJ issues more than six months old are not password protected, but are open access on the website.
