- Collaborate with stakeholders to obtain client referrals
- Complete strength-based occupational therapy assessments
- Develop client-centered and strengths-based treatment goals
- Facilitate therapeutic interventions in school, home and community-based settings
- Identify community resources and facilitate community linkages for youth clients
- Maintain oral and written communication regarding clients as needed with educational personnel, care coordinators, parents and guardians and community agencies
- Provide consultation to families and community partners with client permission to increase generalization of therapeutic strategies for increased success across educational, vocational, and social contexts
- Complete documentation and billing in a timely fashion according to funders standards in the AVATAR, CMS, or other billing and documentation systems
- Oversee and maintain organized working files on all assigned clients
- Participate in quality assurance activities to ensure quality of services
- Attend scheduled meetings for direct individual and group clinical supervision, multi-disciplinary staff meetings, interagency collaboration, evaluation reporting, and staff development and training
- Represent OTTP-SF in community meetings to increase interagency collaboration
- Maintain professional behavior at all times
- Other duties as needed
- Regular attendance is required

Environmental Conditions (Working Conditions)

This position entails working with children, youth and young adults with emotional and behavioral needs in home, school and community settings.

Physical Requirements

This position entails sitting, standing and walking.

Mental Requirements

This job requires that the individual be able to maintain appropriate work pace to complete the assigned work load, perform varied and complex tasks, relate to other people beyond giving and receiving instruction, effectively influence people on a consistent basis, make generalizations, evaluations or decisions without immediate supervision, accept and carry out responsibility for direction, control, and planning, communicate effectively, and adjust to every changing priorities.
