Sub: Extension of provisional temporary approval of affiliation to following law colleges for the academic year 2018-2019.

Sir,

This is with reference to the above mentioned subject regarding extension of provisional approval of affiliation to the **following law colleges** which have already applied for extension of approval of affiliation for the academic year 2018-19 and wherein the inspection of the Bar Council of India is pending at the moment or wherein after inspection, the report of the inspection committee is awaited.

The matter relating to colleges similarly placed were considered by the Bar Council of India at its meeting held on 25th & 26th May 2018. The resolution passed was as follows:

"RESOLVED that colleges whose inspection fee has been deposited, application for extension of approval of affiliation is pending, no inspection could be done or the inspection has been done, but inspection report could not be placed before the Legal Education Committee or the Standing Committee for its consideration, then such colleges may continue to admit students only for the academic year 2018-2019. This will apply only in case where affiliation has been granted by the University which of course shall be subject to the inspection to be made by the Bar Council of India subsequently."

Since your university has given affiliation for the year 2018-2019 to the **following law colleges**, you are requested to allow **them** to admit students in concerned course/s with existing sections for the academic year 2018-2019.

Admission process may be allowed only for those law colleges who have been approved by Bar Council of India including the batch names of the colleges mentioned below and or those law colleges who have been otherwise issued individual approval letters.
