1	1. The total number of sections of the school shall be restricted to 28 as per appendix – V of the affiliation bye laws. Further, the school has filled the intake as 110. However, numbers of the students per sections shall be restricted to 40 as per Board rule 4.8 of the affiliation bye-laws
2	2. As per the review report, some toilets are under construction and there is no partition in the boys urinals. Thus, the school is directed to complete the construction work and remove the material from the school premises within 03 months and submit the compliance.
3	3. The school is required to develop its playground area with proper drainage system within 03 months and submit the compliance.
4	4. The composite science lab is under sized. Thus, the school is required to set-up the same as per SoP within 03 months and submit the compliance
5	5. As per the virtual videography, school has constructed ramp to access first floor. However, ramp on the ground level is not covered in the video and school does not have ramp/lift to access first floor to upper floors. Thus, the school is directed to construct the

	ramp/lift with provisions laid down in RPWD Act within 03 months and submit the compliance.
