## California Resident's Rights under California Consumer Privacy Act (CCPA/CPRA)

1. The right to know a company's data collection and sales practices in connection with the requesting consumer, including the categories of personal information collected, the source of the information, the use of the information and, if the information was disclosed or sold to third parties, the categories of personal information disclosed or sold to third parties of third parties to whom such information was disclosed or sold;

## **Kind Lending**

- 2. The right to request a copy of the specific personal information collected about them during the 12 months before their request;
- 3. The right to opt out of allowing such businesses to sell their information to third parties;
- 4. The right to have their personal information deleted (subject to exceptions); and
- 5. The right to equal service and price. Business is prohibited from failing to provide equal service and pricing to consumers that exercise their rights under the CCPA.
- 6. The right to correct inaccurate information.
- 7. The right to limit the data collected and/or processed by the business; and
- 8. The right to object to automated decision-making technology
