What is a cookie? We make use of cookies on this website. A cookie is a simple small file that is sent along with pages of this website [and / or Flash applications] and is stored by your browser on your hard drive of your computer. The information stored therein can be sent back to our servers on a subsequent visit.

Use of permanent cookies:

With the help of a permanent cookie we can recognize you when you visit our website again. The website can therefore be specially set to your preferences. Even if you have given permission to place cookies, we can remember this by means of a cookie. This means you do not have to repeat your preferences all the time, which saves you time and makes it easier to use our website. You can remove permanent cookies via the settings of your browser.

Use of session cookies:

Tracking cookies from ourselves:

With your permission, we place a cookie on your equipment, which can be retrieved as soon as you visit a website from our network. This allows us to find out that in addition to our website you have also been on the relevant other website (s) from our network. The profile built up by this is not linked to your name, address, e-mail address and the like, but only serves to match advertisements to your profile, so that they are as relevant as possible to you.

Tracking cookies from our advertisers:

With your permission, our advertisers place" tracking cookies "on your equipment. They use these cookies to keep track of which pages you visit from their network, in order to build up a profile of your online surfing behavior. This profile is partly built up on the basis of comparable information that they receive from your visit to other websites in their network. This profile is not linked to your name, address, e-mail address and the like as known to us, but only serves to match advertisements to your profile so that they are as relevant as possible to you.

Google services:

Through our website, a cookie is placed from the American company Google, as part of the" Analytics, Ads, Remarketing and Tag Manager" services.
