On 27 June 2023, ARISE Plus Cambodia successfully hosted its 5th PSC meeting to discuss the project's progress and achievements, as well as offer guidance for further implementation as we near the end of the project in March 2024.

Under the chairmanship of **H.E. Sok Sopheak**, Secretary of State, Ministry of Commerce (MoC), and **Mr. Bryan Fornari**, Head of Cooperation, European Union (EU) Delegation to Cambodia, the meeting was joined by committee members and partners, including representatives from the MoC, Ministry of Economy and Finance (MEF), Ministry of Industry Science Technology and Innovation (MISTI), Ministry of Agriculture, Forestry and Fisheries (MAFF), General Department of Customs and Excise (GDCE), the EU Delegation to Cambodia, Cambodia Chamber of Commerce (CCC), EuroCham Cambodia and GIZ.

It was noted during the meeting that, as of 15 June 2023, the project has achieved over 80% of its implementation with great results. Participants acknowledged the commitment and immense effort made by all stakeholders and commended the project's outcomes over the past several years.

We take this opportunity to thank the Chair, the committee members, and partners for their participation and valuable input in guiding the implementation and strategic direction for future cooperation under the project.



ARISE Plus Cambodia joined the Ministry of Commerce (MoC) to host **dissemination workshops on the "National Cashew Policy 2022-2027"** in Kampong Thom, Kampong Cham, and Preah Vihear provinces, on 24-26 October 2023.

The workshops were organized to introduce the "National Cashew Policy 2022-2027" to stakeholders in the cashew sector at both national and sub-national levels to better understand the policy and its strategies, as well as to foster cooperation among stakeholders and institutions to promote the Cambodian cashew sector nationally and globally, expand cashew exports, and access new market opportunities.

On 9-10 May 2023, an awareness training on "Applying for Import and Export Permit on NSW for Manufacturers and Pharmaceuticals" was held.

The event was co-organized by the Ministry of Health (MoH) and ARISE Plus Cambodia, in collaboration with the NSW Secretariat and GUUD – the developer of the NSW, and presided over by **H.E. Or Vandine**, the MoH Secretary of State.

Throughout the training, participants were equipped with knowledge of the regulatory requirements for permit applications as well as the NSW and its operational and functional specifications. Participants also learned about the efficiency and effectiveness in applying for import and export permits through this online system.

The event aimed to raise awareness of the program and provided guidance on the application process, its intended benefits among business associations, and the current best trader companies in Cambodia.

Capitalizing on the progress since the official launch of the AEO program, ARISE Plus Cambodia has been assisting GDCE to further develop Standard Operating Procedures for the program.

On 6 October 2023, the ARISE Plus Cambodia team participated in the 6th Steering Committee Meeting for ASYCUDA Modernization, which was held under the chairmanship of H.E. Dr. KUN Nhem, Minister Attached to the Prime Minister and Director General of the General Department of Customs and Excise of Cambodia (GDCE).

The meeting was organized by the GDCE and gathered representatives from relevant development partners to review the progress of modernizing the ASYCUDA system and implementing Pre-Arrival processing (PAP). The strategic direction for further implementation was set, including parameters for maritime consignments under the Digitizing Global Maritime Trade (DGMT) project and express consignments under the Digitizing Global Trade (DGT) project.

PHA Eng Veng**, the GDCE Deputy Director General, to attend the **World Customs Organization (WCO) Technology Conference and Exhibition** held in Hanoi, Vietnam, from 10th to 12th October 2023.

During the conference, which was held under the theme "Embracing the Digital Age: Leveraging Technology, Fostering Innovation, and Nurturing the Next Generation of Customs Professionals", the delegates joined over 1,200 attendees from 95 countries. The participants explored how innovation and technology can support Customs in trade facilitation, protection, revenue collection, and prioritize people in the digital transformation process.

White Book 2024

The two-day **ASEAN-Cambodia Business Summit**, held under the theme of "**Connectivity is Growth in the Mekong Region**", successfully concluded on 29 September 2023. The summit was was organized in collaboration with EuroCham Cambodia, European Union Delegation to Cambodia and ARISE Plus Cambodia.

Experts and leaders from the public and private sectors, including high-level guests from the Cambodian government, specifically **H.E. Dr. AUN Pornmoniroth**, Deputy Prime Minister, Minister of Economy and Finance and **H.E. CHAM Nimul**, Minister of Commerce, European Union (EU) officials, business representatives from Europe and the Mekong region, and officials from the ASEAN Secretariat, came together to present and discuss on various topics related to economic challenges and opportunities, as well as to foster economic integration within the region and beyond.

The event also saw the launch of **the White Book 2024**, authored by EuroCham Cambodia with financial support from the EU and the German Federal Ministry of Economic Cooperation and Development (BMZ). This year's White Book contains 78 policy recommendations, including new, updated, and retained recommendations from previous versions. The recommendations cover a wide range of sectors with the aim of improving the business environment and attracting quality investments to Cambodia.

The **2023 Business Confidence Survey (BCS)** was also released by EuroCham Cambodia. The survey offers an overview of Cambodia's business landscape to both current and potential investors. It also provides valuable insights for decision-makers regarding the private sector's overall perception of the business environment.

Workshop on "TTRI Strategic Business Plan 2024-2028"



Workshop on "TTRI Strategic Business Plan (SBP) 2024-2028

In cooperation with ARISE Plus Cambodia, the Trade Training and Research Institute (TTRI) of the Ministry of Commerce (MoC) concluded two **consultative workshops on the "Strategic Business Plan (SBP) 2024-2028"**.

The first workshop was organized at the national level on 16 August 2023 in Phnom Penh. Another workshop was conducted at the sub-national level on 29 August 2023 in Siem Reap province.

The two workshops gathered key officials and relevant stakeholders, including representatives from the MoC's central and provincial departments, the private sector, and development partners, to discuss key inputs for the plan's formulation. This included setting strategic goals, defining business models and strategic actions, as well as identifying implementation mechanisms.

Training on Digital Economy Framework Agreement Negotiation Preparation

The **ASEAN Digital Economy Framework Agreement (DEFA) training** for Ministry of Commerce (MoC) officials and relevant line ministries has begun.

The much-anticipated DEFA negotiations were launched by the ASEAN Economic Ministers during the 23rd ASEAN Economic Community Council (AECC) meeting in Jakarta, Indonesia, in September 2023.

According to the ASEAN Secretariat, DEFA would be the world's first regional digital economy agreement to enable and protect a digital trade ecosystem that aims to enhance ASEAN's digital transformation and make it a leading digitally connected community and economic bloc.

The ASEAN DEFA Negotiating Committee (NC), chaired by Thailand, consists of lead negotiators from the 10 ASEAN Member States. The first meeting is planned for late 2023, followed by subsequent meetings in 2024 and 2025. The NC is aiming to finalize ASEAN DEFA negotiations by 2025. In preparation for the Cambodian negotiators to get ready for their role in the upcoming negotiations, ARISE Plus Cambodia is collaborating with the MoC to conduct a three-part DEFA training for MoC officials and relevant line ministries.

The training will serve to: (1) introduce Cambodia's stance on commitments made in different forums and ongoing e-commerce negotiations at the World Trade Organization (WTO) under the Joint Statement Initiative (JSI) and review previous commitments made at ASEAN and bilateral levels; (2) evaluate progress in Cambodia's areas of interest; (3) identify areas where laws and regulations need to be updated for DEFA compliance, and; (4) addressing topics without existing dedicated laws or regulations.

The first part of the training for the secretariat concluded on 4 September 2023 with 12 participants. The two-day training covered various recurrent topics of Digital Economy Agreement (DEA) negotiation. The second part of the training is planned for 8 and 10 November 2023 with the same number of participants.

ARISE Plus Cambodia has recently established a **partnership with the Siem Reap - Oddar Meanchey Chamber of Commerce (SROCC)** as part of its continued support for the implementation of the **Public-Private Dialogue (PPD) Mechanism** under the **Government-Private Sector Forum (GPSF)** in Cambodia.

The main objectives of the partnership are to streamline the G-PSF mechanism within a provincial business chamber and strengthen its capacity, especially concerning SME export related issues.

Within this partnership, the project's support for the SROCC included providing administrative and technical support for PPD trainings and workshops for SMEs in Siem Reap province. The project equipped the chamber with ICT equipment and trained stakeholders on relevant ICT skills for virtual meetings, while offering technical and advisory support for documenting and submitting SME export issues in coordination with national level counterparts.

This is the fourth collaboration with business associations in Cambodia that aim at promoting the G-PSF and enhancing a strong business-enabling environment in Cambodia, following the partnership

with Cambodia Chamber of Commerce (CCC), Cambodia Rice Federation (CRF) and the Battambang Chamber of Commerce (BCC).
