CONSIDER PAYING BILLS OF THE PREVIOUS MONTH: Landis informed Council that the next set of bills will be delivered on Thursday, May 18, 2023. Knapp presented one construction estimate in the amount of \$91,081.98 from West Texas Utility for Well 7A.
