VENUE

The Constantia Wine Route plays host to sumptuous views, food, wine and travel experiences. A gourmand's paradise, with some of history's favoUrite wine and unique travel experiences, Constantia has always been prime real estate for love.

The Constantia Mist Vineyard Estate offers two spectacular outdoor venues that vary in size and scenic beauty. These two venues are suitable for a variety of events:



VENUE 1

The first site is a large, open lawn that is roughly 50m in length (1000m²) and has a beautiful view of the surrounding vineyard, the Constantia Valley, and the back of Table Mountain. Comfortably seats 250 pax maximum.



VENUE 2

The second site is a terraced lawn leading onto a large secluded field, roughly 50m in length (1000m²). This venue is perfect for a reception, due to the fact that it is sheltered from the wind by the surrounding trees. Venue 2 is located only 15m from Venue 1. Comfortably seats 250 pax maximum.

MAKING USE OF BOTH VENUES

Wedding venues 1 and 2 combined are available for a once-off fee of R70 000, with an additional R5 500 levy (per day for both venues) for set-up and take-down.

Rate is for hiring the venue only and excludes catering, marquee, bar, decor, etc. through one of our two preferred event providers. These costs are for the client's account.

MAKING USE OF ONE VENUE (EITHER VENUE 1 OR VENUE 2)

Wedding Venue 1 or 2 is available for R66 000 with an additional R5 500 levy (per day) for set-up and take-down.

Rate is for hiring the venue only and excludes catering, marquee, bar, decor, etc. through one of our two preferred event providers. These costs are for the client's account.



TERMS & CONDITIONS

VENUE:

- All functions must end at 11pm prompt.
- Sunday nights - no functions permitted, only day functions ending 6pm.
- All events must be coordinated by an Events Planner.
- Viewing of the venue is by appointment (Monday to Friday from 09:30 to 15:00). No weekend viewing.
- All events must employ a clean-up crew. The venue must be left in the same condition in which it was found.
- Failure to do so will result in additional costs and penalties to the client.
- The client shall be responsible for any excessive damage to property or furniture by any act or omission of the client or the client's guests or employees of the client. The client will be responsible for full payment of repair or replacement costs, as agreed with the site manager.

SETUP

-All arrangements must be confirmed by email with the site manager.

-The Constantia Mist Vineyard Estate will not be held liable for any loss or damage to the client's or client's guests personal or private belongings.





BOOKING PROCEDURE

Bookings will only be confirmed once the client has signed a copy of the Terms and Conditions and has paid a 20% deposit.

-Cancellation:

- Up to 60 days before function - full deposit refunded.
- Within 60 days prior to the event - no refund of deposit.

PAYMENT

Full payment must occur before set-up can commence. The site manager is entitled to postpone an event until such time that payment occurs.

NOISE

The event planner must acquire a noise permit. Proof of this permit needs to be sent to the site manager prior to the event in order for an event to commence.

Due to strict local noise regulations, all music must end at the prescribed time of 11pm. We reserve the right to regulate the volume of all music during the course of the function.

Failure to adhere to requests by the site manager, to turn down the volume of loud music, will lead to immediate termination of loud music for the duration of the function.



WEATHER

By signing these Terms and Conditions, the client is in agreement that Constantia Mist Vineyard Estate does not take any responsibility for the effect that the weather will have on the event.

PARKING

There is limited parking available on the estate (guests to be encouraged to use Uber). Guests use the parking at Constantia Village and Uber the 4km to Constantia Mist Vineyard Estate.

Due to the narrow width of the road, a shuttle service is advised to transport guests to and from the main entrance. This shuttle must be organized by the events manager.
