## A Message from Our President

As 2023 winds down, we are excited for the opportunities awaiting us in 2024 to care for our beneficiaries while improving quality outcomes and reducing unnecessary costs. Next year will represent the first time since 2019 that LTC ACO has not been impacted by the public health emergency as a result of COVID. I believe this dynamic will produce a meaningful reduction in costs over previous years during the pandemic.

As most of you know, we have invested heavily in a predictive analytics tool called ClosedLoop. Earlier this year, we rolled out two models to help us predict a) the risk of hospitalization and b) the use of end-of-life care. Soon we'll release a third model predicated around medication management and polypharmacy. Our goal is to release the results of the first two models by the end of Q1 2024. While the results will be preliminary, we are hopeful they will demonstrate the benefit of this type of data and encourage other providers to participate and/or engage with the ClosedLoop data more closely.



Finally, we will remain relentless in our efforts to work with the Centers for Medicare and Medicaid Services to ensure greater transparency in beneficiary attribution, as well as better programmatic alignment of the Medicare Shared Savings Program with the population we currently serve. We also plan to advocate for attribution of patients seen by advanced practice practitioners only without the need for a qualifying physician visit. This will increase overall attribution and create additional meaningful savings for many, if not most, LTC ACO participating providers.

I want to thank you for your participation in LTC ACO and the exceptional care extended to our beneficiaries. Wishing you and your families a joyous and healthy holiday season.
