A Trip to the Brookfield Zoo is a "family first" at age 23!

CSS secures a state grant to provide family with handicap accessible vehicle.

Zenny looked at her daughter in the rearview mirror. At age 23, she knew it would be Brianna's first time at the zoo. It was strange to think that something this common for most families wouldn't happen for them until today. But finally, they had safe, reliable transportation to make the outing easy.



Brianna is fragile and cannot stand or walk on her own. She is diagnosed with 1P36 Deletion Syndrome, which is a form of cerebral palsy. She relies on a wheelchair. So when Zenny's car conked out and needed costly repairs, her CSS coordinator, Stephanie, encouraged her to apply for an Illinois Vehicle Modification Grant. This would allow Zenny to buy a car specially equipped for Brianna's wheelchair.

Stephanie helped secure the necessary quotes and completed the tedious paperwork.

Zenny knew that approval for the grant wasn't a guarantee, and Stephanie cautioned that news can sometimes take up to a year. But with good fortune and a lot of FAITH, Zenny got positive news from the state in an unbelievable THREE WEEKS' time; she was eligible for a sizeable grant.

Today, Zenny says she and Brianna feel like movie stars driving in their new van. Brianna can be safely scooted up the ramp and remain in her wheelchair during the ride. This provides safety, comfort, and dignity for her.

Also, Zenny no longer has to lift Brianna and strain her back. Even though Brianna is petite, her wheelchair alone weighs 80 pounds. It's a lot for this mom, who is just 5'1", to handle.

Now, instead of limiting their outings to frequent, and mundane, visits to the doctor, Zenny and Brianna are making plans to see the sights. It's a whole new world for them to explore together.
