# CITY OF THORP REGULAR CITY COUNCIL MEETING MINUTES MONDAY, FEBRUARY 14, 2022 AT 6:30PM AT THORP CITY HALL

#### **OLD BUSINESS**

5. Short Elliot Hendrickson Updates

David Schofield from SEH updated the Council on the W. School Street and N. Church Street Utility Improvement Project. They are proceeding with design of the roadways and are preparing a preliminary assessment report for the March meeting. The application for DNR Lead Service Line Replacement Program funds was submitted and the award of program funds is expected in mid-March. The PSC Water Loss Audit was completed and filed with the PSC as required.

#### **NEW BUSINESS**

6. Update Regarding CDBG-PF Income Survey for School Street and Church Street

David Schofield from SEH updated Council on the income survey for the CDBG application regarding W. School Street and N. Church Street. The income survey was completed and did not attain the required 51.0% Low to Moderate Income and is therefore not eligible for the WisDOA Community Development Block Grant for Public Facilities this cycle. Several options to move forward were presented to Council which were: Proceed with the project with local funding, apply for United States Department of Agriculture Rural Development funding, apply for DNR Safe Drinking Water Loan Program and/or DNR Clean Water Fund funding. A new income survey may be completed for CDBG-PF in 2023. All fundings could be combined or the project can be dropped entirely.

7. <u>Discussion and possible action regarding USDA-RD funding for Wastewater Treatment Plant and Upcoming Street Projects</u>

Clean Water funding has been accepted by the DNR. \$768,466 in principal forgiveness (grant) has been allocated to the WWTP project. The remaining costs could be funded with a low interest loan. Rural Development has potential for significantly more grant money (estimated around \$1.5 million) available for the WWTP through Rural Development. These funds cannot be combined with the grant from DNR or CWF program. There are increased costs associated with applying for this grant money, but based on preliminary numbers, still a large net gain. Combining the WWTP with the upcoming street projects was discussed.

M/M/S (Korn, Lawcewicz) to enter into an agreement with Short Elliott Hendrickson Tasks 1 – 4 of the agreement for \$60,000 for grant application for USDA Rural Development Funding Assistance. Motion passed 4-0.

8. <u>Discussion and possible action to renew the CCEDC (Clark County Economic Development Corporation)</u> 2022 Annual Membership.

M/M/S (Lawcewicz, Korn) to renew the 2022 Annual Membership with Clark County Economic Development. Motion passed 4-0.
