OLD BUSINESS

5. SEH project updates

Paulette Hedrington updated Council on the W. School and N. Church Street Improvements Project. Haas Sons, Inc has completed road reconstruction and paving is scheduled for completion. Project is scheduled to reach final completion before June 30, 2023. DNR Safe Drinking Water and Clean Water Fund funding is ongoing, including disbursement requests, payroll reviews and DNR compliance requirements. The Wastewater Treatment Plant Project construction started in mid-May. DNR approved sludge land application sites in May but has restricted application to the period from July to September. SEH has confirmed with DNR that if depth to groundwater can be documented greater than the minimum 3 feet required by the NR Code, land application can occur before July. The USDA RD Funding for the WWTP Public Interest Waiver was posted for comment and is now closed. Obligation for additional funding has been prepared by USDA-RD and will be presented to City after waiver is approved. If the public interest waiver is not successful in a timely manner, an ITA/PERF has been approved by DNR which will allow for a Clean Water Fund application to cover additional costs.

Three letters were sent out to contractors for the blacktop bids with only one bid returned. The bid was from Senn Blacktop, Inc for \$24,975 for 740 square yards. They proposed to do the work between August 14 – October 11, 2023.

M/M/S (Abramczak, Einhorn) to approve the bid from Senn Blacktop, Inc for \$24,975. Motion passed 4 - 0.
