Integrated with ScriptPro's SP Central Point of Sale System, Electronic Signature Point of Sale securely processes credit, debit, and FSA/HSA card transactions*. The large touchscreen display allows patients to request counseling and sign for payment, as well as sign forms (HIPAA acknowledgement and other customized pharmacy forms supported). Signatures are electronically recorded and easily retrievable for audit purposes.

Patients appreciate the easy-to-read and intuitive design, while pharmacy staff values the time-saving electronic signature capture and integrated card processing. And, the device's enhanced security is appreciated by everyone!

The Importance of Implementing EMV

- In October 2015, payment card processors shifted liability to merchants that had not transitioned to the EMV standard. EMV is an enhanced security framework that defines payment interaction between chip cards and payment devices; EMV stands for EuroPay, MasterCard, and Visa.
- EMV reduces a merchant's liability in the case of payment card data being misused, lost, or stolen from its facility.
- When properly configured, Electronic Signature Point of Sale enhances card data security by complying with SAQ-P2PE standards. P2PE provides merchants with strong cryptographic protection of payment card data from the point it is used at a payment terminal until that data reaches the secure point of decryption.
- Electronic Signature Point of Sale also supports Near Field Communication (NFC) payments such as ApplePay and Google Wallet.

Other Data Security Details

- SP Central does not store cardholder data (CHD) within logs, database, or otherwise; system memory is scrubbed of CHD after being transferred to VeriFone PAYware (connection is encrypted via SSL).
- ScriptPro's Payment Card Sub-System (PCSS) is PA-DSS certified (PA-DSS v5.3).
- VeriFone PAYware is compliant with PCI v4.x.

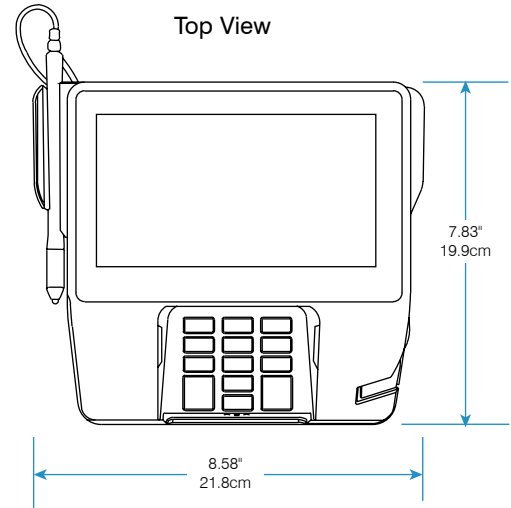

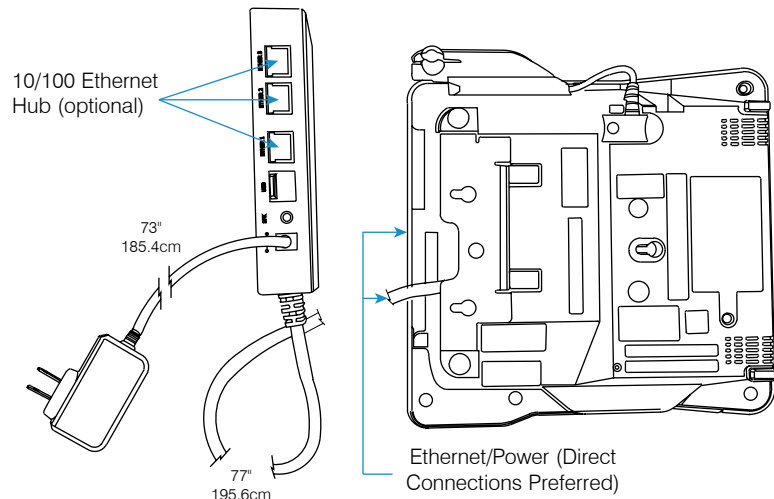

Top View

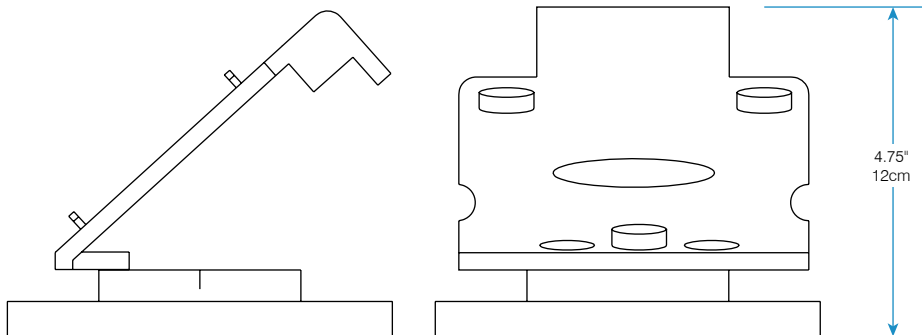


Bottom View
