## Rule 76, Postponed Shows

What is the intent of this rule? It makes no sense these days to prevent additional people from entering our shows. Restricting entries prevents participants who may be able to attend on the new date from bringing in additional money for entries and show fees. There is no magazine deadline to worry about anymore, and the new date can be advertised on FB or the website. We should not prevent interested people from showing with us.

However, with Rule 76 deleted, I would propose adding the following to Rule 75, Rescheduled Shows, so that the rescheduled show doesn't conflict with other show dates in the state, etc.

Add as Rule 75.A.2: Shows rescheduled for any reason must be made up on a date that meets the show approval requirements set forth in Rule 52.C, D and E.
