JPFC reining enrollment has been minimal of 4 to 5 entries at the most with POA's ages 3 to 5 years old performing the last several years. The riders/ponies have 2 goes at the futurity only versus all other shows it is 1 go. Opening the class to any age POA can give adults more options than just showing their young POA's only at futurity in the reining class.
