### **CLIMATE ISSUES WORLDWIDE**

### **SCORECARD OBJECTIVE**

The objective of this scorecard is to evaluate the performance of the fourteen cities in Alameda County in responding to the climate emergency. The scorecard seeks to provide a comprehensive and comparative analysis of each city's performance, highlighting areas of success and identifying opportunities for improvement, with the ultimate goal of fostering a more just, sustainable and resilient Alameda County.

To develop this scorecard, we started by conducting extensive research on the best practices and key performance indicators for cities responding to the climate emergency. We analyzed a wide range of sources, including academic literature, government reports, policies, laws, and expert recommendations, to identify hundreds of potential questions that could be used to evaluate the cities.

We then carefully reviewed and refined this list of questions, taking into consideration factors such as relevance, measurability, and feasibility. Through a thorough screening process, we boiled down the list to the 25 questions that we felt were the most relevant and effective in capturing the cities' performance. For each question, we developed a clear and comprehensive ranking process, taking into account the specific indicators, metrics, and benchmarks that would be used to evaluate the cities' performance. We carefully considered the weighting of each question and the overall scoring system, ensuring that it was fair, transparent, and accurately reflected the importance of each indicator. Throughout the process, we engaged with a wide range of stakeholders, including city officials, climate experts, community groups to ensure that our scorecard was robust, credible, and aligned with the needs and priorities of Alameda County. We also incorporated feedback from peer review and expert consultation to improve the scorecard's validity and reliability.

Overall, we are confident that this scorecard provides a rigorous and comprehensive evaluation of the fourteen cities in Alameda County's response to the climate emergency, and we believe that it can serve as a valuable tool for promoting climate action, accountability, and collaboration across the region.

### HOW TO READ THIS SCORECARD

The scorecard is divided into 25 questions across 6 categories, with each question representing an important aspect of a city's response to the climate emergency. Each question is assigned a score out of 4, with 4 being the highest score possible for each question, indicating strong performance on that question. Each city has the possibility of getting 100 points from the 25 questions.

The scores for each question are color-coded based on the following scheme:

- 4 Green (Yes): Strong performance scores
- 2 Yellow (IP [In Progress]): Moderate performance scores
- 0 Red (No): Weak performance scores

The scorecard includes a mix of generic and numeric questions, with most questions requiring only a generic explanation of the city's performance. However, for the numeric questions, we provide a more detailed explanation, including the percentage range or other relevant metrics, to provide a comprehensive and accurate evaluation of the city's performance. The scorecard also includes a section that highlights the strengths and weaknesses of the city's performance in responding to the climate emergency, as well as recommendations for improvement. This enables cities to understand their performance in detail, identify areas for improvement, and take appropriate action to enhance their response to the climate emergency.


