## **Clerk Report: Dean Stull**

Dean presented the following motion:

Motion: that Session approve Bonnie Johnson to be a Covenant Partner at the recommendation of Pastor Emily Crider.

Motion was made and seconded.

Emily Crider shared reflections on her time meeting with Bonnie in preparation for covenant partnership.

Motion passed.

### Stewardship Update: Kathy Baker

The Stewardship Committee is looking ahead to 2024-25 with an emphasis on the giving of time, talents and financial resources. In addition, the committee will be using "monthly financial commitment" as the language instead of pledging when communicating financial giving.

#### Mercy Ministry Task Force Update: Lisa Schone

Lisa, Debbie and Dean have met and presented the following motion for a first reading.

<u>Motion:</u> On June 18, 2023, Session, at its regular monthly meeting, approved a motion from the Ministry Evaluation and Health Committee (MESH) creating a task force **chartered** to draft a holistic proposal for "Good Samaritan" mercy and justice ministries at Grace Commons Church. The charter for the task force was broad while it included language that seemed to narrow the focus with an emphasis on the "Good Samaritan" mercy and justice ministries of the church.

Session now understands that the charter for the task force was insufficient, that the work of the task force required a higher level of authority, and a broader approach to discern God's will for, and serve the needs of, the missions and ministries of Grace Commons Church.

Session is more fully aware of recent mission and ministry disruptions and desires to understand, address, and honor these areas and the individuals who have invested their time, energy, and resources in them. At the same time, Session desires to be strategic in how and why it encourages and resources its missions and ministries, and desires to utilize and preserve the institutional knowledge from the past, in the present, and into the future.

### Therefore, it is moved that:

- Session disbands the "Good Samaritan" mercy and justice ministries task force that it formed on June 18, 2023; and
- Session forms an Ad Hoc Committee of Session to be known as the Mission Study Committee; and
- for the purpose of this work the term "missions" will include Grace Commons Local Missions and Global Missions departments, as well as some other ministry areas that the Committee determines are better aligned with or generally interchangeable with the designation "mission;" and
- the Committee will begin its work immediately and complete its work by July 31, 2024; and
- the Committee will be composed of three or more serving elders and Anthony Ceder, the Pastor/Head of Staff; and
- the initial serving elders will be Debbie Carosella, Lynnie Parr, and Lisa Schone; and

- the initial Committee will recruit 3 to 6 lay leaders, volunteers, staff and current or previous elders, trustees, deacons with expertise and experience within the mission areas under study to join the Committee; and
- the Committee will interact with church volunteers and staff working in selected mission areas when deemed necessary; and
- the Committee will look outside of the church for best practices and ongoing thriving missions as references for the Committee's work; and
- the Committee will focus on a strategic evaluation of how Grace Commons' missions are aligned
  with the strategic focus of the church; how they integrate with the mission, vision, and goals of
  the church; how they interact with each other; and how they are and should be resourced with
  staff, volunteers, and physical resources; and
- the final work product of the Committee will be a report to Session containing an overview of the
  completed evaluation with recommendations focused on the strategic implications of their review
  such as considerations of resource allocations, ministry evaluations, organizational structure,
  ministry short/mid/long term goals and objectives; and
- it is anticipated that the Committee's work will be a template or guide for future work to align, resource, and organize new mission or ministry areas.

There was a brief discussion. This motion will be presented at the March Session meeting for a final vote.

#### **Executive Session:**

Dean presented the following motion for approval.

MOTION: to move to executive session for a confidential update.

The motion was made and seconded.

The Motion passed.

Following Executive Session, the statement below was presented by the Clerk to be included in the minutes of the general.

Session was informed by staff at the Jan 11, 2024 Session meeting that an alleged registered sex offender was attending church and involved in church programs. Understanding its responsibility to protect the congregation and walk alongside individuals struggling with challenges such as this, Session asked staff to investigate both the legal issues and internal policies currently guiding the church in situations such as this.

At today's meeting, Feb 8, 2024, Session was appraised of the status of the internal review being conducted by Trustees and staff on this topic. Session anticipates that this review will be completed and recommendations presented to Session at the meeting scheduled for Mar 14, 2024.

#### **MESH: Steve Rice**

Steve introduced Shelly Zumsteg, the moderator of the Global Missions committee. Shelly provided an update on the status of Global Missions.

**TED report: Topher Fox** 

The nominating process to select elders, deacons and trustees for the Class of 2027 is underway. There are

currently 14 recommendations and interviews will begin in March.

Worship/Misc Topics: Anthony

Going forward Anthony will be seeking elder input on a variety of topics – that include worship and other issues.

Regarding the facilities, Anthony asked for 2 elders to work with 2 trustees to cast vision on space usage in the

main building.

The elders agreed that future decisions related to building closures will be made by the facility manager in

consultation with the Business Manager and the President of Trustees.

Anthony presented the following motion:

Motion: Session encourages the idea of passing offering plates during the worship service as an act of

worship at the discretion of the Pastor/Head of Staff.
