


Secretary's Report

 - Now holding the Annual CLID meeting


Old Business

- Wrote the "CLID 2017 Treasure's Report"
 - Provides a historical 10-yr review of data
 - Allows for trend analysis data for budget

- Zebra Mussel Veliger Testing
 - **■** Funded by Morrison Cty
 - Sampled three locations
 - 25 June: Negative
 - 18 July: Pending

- Lake Shamineau High-Water Study
 - Residents have reported ~\$1.230 million in expenses due to high water level
 - SLID hired engineering firm to study causes and solutions
 - Goal: lower Lake Shamineau to a level of 12 inches below OHWL (initially 18 inches)
 - Engineer (hydrologist) confirms Crookneck and Shamineau Lakes water levels track over time with Crookneck being higher

- Lake Shamineau High-Water Study (cont)
 - Initial feedback from ~35 CLID members
 - Range from "perhaps a foot from current level" to "inches" to "leave nature be"
 - **■** Concerns include:
 - High-water increases property value vs. swamp in bays
 - Increased utilization of lake
 - Cost savings due to less weed harvesting
 - Less work removing cut off weeds
 - Eliminate majority of the east marsh habitat

- Lake Shamineau High-Water Study (cont)
 - Already invested in shoreline erosion mitigation
 - Lower it now what happens when have a drought lasting one or more years
 - Effect on shallow sand point wells
 - Effect on water quality as decrease volume
 - Native weeds are now at a manageable level
 - Effect on fish habitat ... winter kill
 - Increased potential for ground water to leach from Transfer Station into Crookneck as Lena Lake hydrostatic pressure increases/changes

- Lake Shamineau High-Water Study (cont)
 - High water is approaching my cabin
 - Increased ice jamming
 - Water in basement; filled in basement due to high water few years ago
 - Dock is at its limit
 - Lost my sandy beach

- Lake Shamineau High-Water Study (cont)
 - County adopt an exception to permitting program allowing a property owner to raise their property up without applying set-back rules
 - County est. funding program for property owners similar to septic system up-grade program

- Lake Shamineau High-Water Study (cont)
