

ENTRY & HOUSE POLICIES



The following are the house & entry rules that apply at Chin Chin Club. You are obliged to comply with these rules; otherwise, the management reserves the right to deny access. By entering the venue, you tacitly agree to abide by the applicable house & entry rules and General Terms and Conditions of Chin Chin Group (www.chinchingroup.nl). Violation of these rules may be reported to the police, and future access can be denied. We do not grant access to individuals who, in any way, cause inconvenience to our neighbors or have caused issues in the past.

AGE

The minimum age of entry during club nights on Thursdays is 21, and on Fridays and Saturdays, the minimum age of entry during club nights is 23. Be aware that in case of doubt, our host retains the right to ask for your identification to verify your age.

ATTITUDE

In addition to all our daily social standards and values, we expect our visitors to be tolerant and positive towards other guests present at our location, regardless of their origin, culture, sex, sexual orientation, religion and age.

CAMERAS

There are cameras in various places in the building. Anyone visiting Chin Chin Club agrees to the camera surveillance. In addition to security purposes, please be aware that by entering the Chin Chin Club, you consent to be filmed and/or photographed. The images and footage captured may be used as advertising material for Chin Chin Club and may also be shared with third parties for promotional purposes. If you have any concerns regarding this matter, please inform our staff upon entry. In case of calamities, these recordings may be shown as support material to third parties.

CONSUMPTION

Please note that when you visit Chin Chin Club, we kindly ask that you make a purchase.

GROUPS

The management of Chin Chin Club keeps the right to deny access to groups larger than 4 people.

DRESSCODE

Chin Chin Club's dress code is relaxed chic or glam. An elegant outfit is appreciated. We deny access to Chin Chin Club if you are wearing beachwear, shorts, caps, a shoulder bag, or sportswear. A tie, suit, or evening dress is not mandatory, but they are nonetheless welcome. Furthermore, your clothes should look presentable. Chin Chin Club has the right to refuse access to guests with damaged clothing and/or an unhealthy appearance.

DRUGS

The use, sale or possession of any narcotic drugs is strictly prohibited. Narcotic drugs are taken and placed in a police locker.

FIRST AID KIT

A first aid kit can be found with the management at Chin Chin Club. The management is trained to provide first aid interventions.

FIRE SAFETY

The emergency fire safety and evacuation instructions are available for guests to read. In case of a fire, please do not panic. Warn an employee immediately and press the nearest fire alarm.

INSPECTION

At the entrance of the building, but also inside, there may be the possibility of having to submit to an inspection. This check is set to protect everyone in terms of overall security. Cooperation is obligated, guests that do not cooperate will be denied access.

LOITERING

We have the right to deny any access to Chin Chin Club in case of suspicions of unpleasant loiter.

LOST & FOUND

Found items need to be handed in.

PARKING/BICYCLE RACKS

You must park your vehicle at the designated places in such a way that no third parties are affected. If this is not done, you are at risk of your vehicle being removed.

TRADE IN GOODS

It is prohibited to trade goods in or surrounding the property of Chin Chin Club and/or to be guilty of dealing.

PROPERTIES

It is prohibited to take properties from Chin Chin Club outside of the building. This includes items such as leftover food, beverages, and glassware. In case of damage to our property, you are liable for repair or renewal costs. You are responsible for your own belongings, and we do not accept liability for theft, loss, and/or damage.

SOUND (LEVEL)

In several rooms of Chin Chin Club, sound levels exceeding 85 dB (A-weighted) may be produced. Our company does not take responsibility for any consequences that may occur to your hearing. Staying in these rooms is therefore at your own risk. Earplugs are available at the entrance.

UNWANTED INTIMACIES

Unwanted intimacies (sexual harassment) are not tolerated at Chin Chin Club. Individuals who engage in such behavior will be promptly removed from the premises, and future access to the club will be denied.

WEAPONS

Using or wearing any weapon is strictly forbidden at Chin Chin Club. If a firearm is detected, the police will be called immediately.

INTOXICATION

Visitors who are visibly affected by alcohol and/or drugs will be denied access.
