Recent studies show that multiple mycotoxins occur in more than half of cereal grain samples, compelling global grain handlers and processors to adapt preventive monitoring strategies for aflatoxin, vomitoxin (DON), fumonisin, ochratoxin A, T-2, HT-2 and zearalenone.

Aflatoxin is known to cause immune suppression, acute liver failure and is a potent carcinogen even at low concentrations. When ochratoxin A co-occurs with aflatoxin in poultry feed, a significant decrease in growth rate (P less than 0.05) and a rise in flock mortality have been observed. The ability to detect and quantify multiple mycotoxins enables on-time raw materials management, saving valuable time and rework, while protecting livestock health and safety.

Myco 5-in-1 PLUS enables grain and feed managers to obtain critical quality data before raw materials are accepted into storage or processing. Using a single, 30-second water-based extraction, the Vertu TOUCH delivers fully quantitative results for up to SIX toxins in less than 10 minutes, with a 77% savings in time and consumables costs.
