Leader's welcome



Hello and welcome to the winter edition of Town & Country.

The past couple of months have been filled with terrible news from Israel and Palestine. The horror of war is again upon the people in both these countries. I am sure you all hope, like me, that someone will soon be able to stop the aggression, the attacks, the retaliation and start to work for reconciliation and peace, a lasting peace that will endure.

Locally, we've been working hard on the Council Plan, which reflects our manifesto. It is ambitious and focuses on many key issues – climate change, the cost of living, children's and youth services, education, adult services, housing, business and arts and leisure to name just a few. We want to achieve as much as possible in four years.

Financially, the next couple of years are not going to be easy, and difficult decisions will have to be made.

I will be visiting key places in the borough at the start of next year to talk to you about the budget and listen to your concerns. If you have any questions, you can come and talk to us.

If you are struggling with the cost of living, please know there is help available. Turn to page nine for details on advice and support that could help you this winter.

Our priorities include making the council more open, transparent and inclusive. We

promised we would involve residents by taking the work of the council out to the community, we have already done this and will continue to do so. We want to increase residents' knowledge of the hard work of the council, it's not only about potholes, bins and grass cutting. Unless you need support for adult social care and children's services, it's possible that you might not know much about these vital services.

I would encourage you to contact your local councillor, who is always available for help, support and signposting. You can find their contact information on the council's website: www.bracknell-forest.gov.uk and search 'find your councillor'.

At Christmas time, we produce 30 per cent more waste in the UK compared to the rest of the year. You can read more about how to recycle accurately, thereby helping reduce our recycling costs and saving you money, on pages 22-23.

Growing together and shaping tomorrow through our new Council Plan

The council's new priorities for the borough have just been agreed and will look to improve local health, the environment, communities and our economy over the next four years.

The Council Plan, which sets out where the council will focus its attention, time and money, was agreed at the end of November. It aligns to the Labour administration's election manifesto.

The overall vision for the council in this period is to grow together and shape tomorrow. The plan has three key themes in line with that vision:

- Engaged and healthy communities
- Thriving and connected economy
- Green and sustainable environment

Key projects under these themes include:

- Building and opening a new supported living service in Birch Hill (called Bridgewell).
- A new SEND school at Buckler's Park.
- Creating more than 80 new affordable and/or social rent homes in Market Street

and additional affordable homes on the former depot site in Old Bracknell Lane West.

- Working with the NHS to create a new health facility in the town centre.
- Enabling the delivery of a new community hub in Warfield alongside Warfield Parish Council.
- Working with Bracknell Regeneration Partnership to provide some 'meanwhile' activity on the former Bentalls site in the town centre.
- Researching the possibility of providing new energy schemes at the old London Road landfill site, including a solar array and charging hub.

The plan details how the council will monitor the progress being made in achieving its goals for the borough. These include: an increase in recycling the correct items, reducing the number of people sleeping rough and increasing the number of affordable homes, improving education outcomes for disadvantaged children and those in care, reducing carbon emissions, increasing bus use, increasing the number of electrical vehicle chargers, and increasing the effectiveness of mental health support as well as other physical health measures.

It also sets out that reducing unemployment further and increasing the skills and training

of local people are key ambitions over the next four years, as well as increasing the number of people visiting the town centre.

The council cannot achieve these ambitions on its own, so will work with other organisations like the NHS, community groups and businesses on relevant priorities and projects.

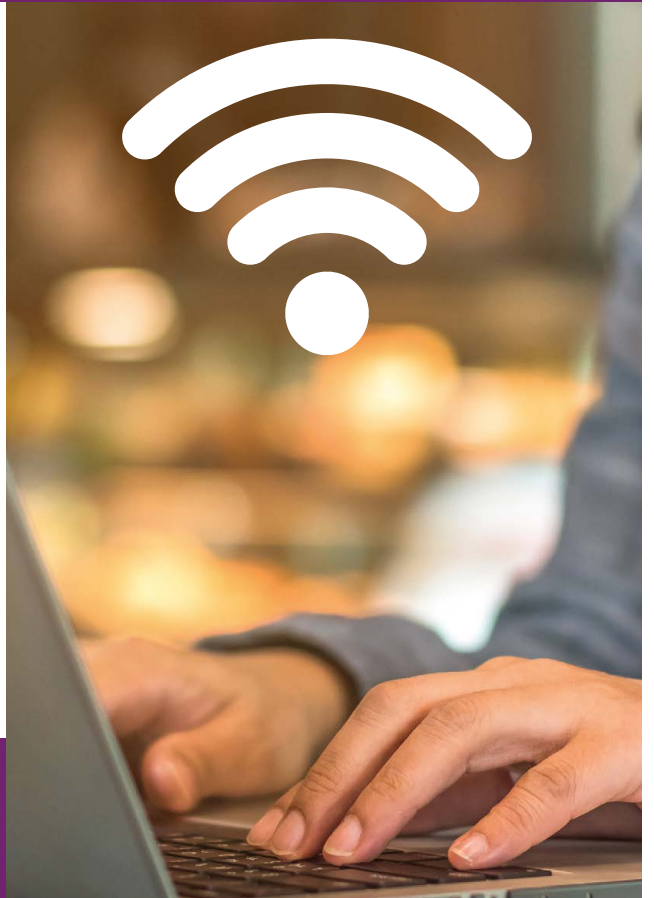

Bracknell Forest Council's financial position

Like most other local authorities across the country, Bracknell Forest Council is facing a challenging financial position - with unprecedented pressure on its budget.

Earlier this year, the council was facing a financial gap of around £4m. However, due to lots of hard work behind the scenes, this had reduced to around £2m.

While this brings the council closer to balancing its books, and there is no current risk of bankruptcy (called a section 114 notice), it is still in a difficult financial position. A position it has never been in before.

This deficit is largely due to rising costs, rising inflation, increased service demand and years of underfunding from central government.

Like everyone, the council is not exempt from the rise in the cost of living. The high rate of inflation also affects all council services.

In addition to inflationary costs, the council's budget is affected each year by other cost pressures, notably relating to increased demand for services. Alongside the higher demand for social care services, prices for care packages are rising much faster than inflation.

Additionally, more people in the borough have care needs that the council must meet, including children in care or with special educational needs and disabilities (SEND), and adults with learning difficulties or physical disabilities. This care and support is non-negotiable and must be prioritised, but still adds to council budget pressures.

Another pressure has come from the amount of business rates collected dropping drastically. The national Valuation Office Agency (VOA) determines business rates for all businesses, and continuously re-assesses how much companies are paying. A number of significant businesses in the borough have been reassessed this year and so the council must make refunds backdated to 2017 - totalling several million pounds.

Changes have already taken place with immediate effect to help reduce overspending.

This includes making sure staff only spend on essential items necessary to provide frontline services and holding vacancies where possible.

Cllr Kathryn Neil, executive member for finance and business change, said: "Although the current year's financial position is particularly challenging, we are in a strong place compared to similar local authorities.

"Some councils have declared bankruptcy, thankfully Bracknell Forest Council is not in

this position, but we want to be honest and transparent with our residents about our current financial situation.

"We are in an unprecedented financial position with a £2m gap due to spiralling costs, rising inflation and increased demand for our services.

"While these are not factors within our control, we must address the budget gap. This means that over the coming months we will have to make some difficult decisions and look very carefully at what we can afford to prioritise for the remainder of this year and future years."

The council's interim financial position will continue to be monitored by senior staff weekly. Additional spending controls will be put in place, where necessary.

In parallel, work is being carried out on the budget for 2024/25. Many of the pressures being faced in the current year will inevitably impact on next year too. Draft budget proposals will be put to the executive in December, where they will be asked to approve a public consultation on the plans.

Our executive councillors will visit key places in the borough at the start of next year, to talk to residents and answer any questions they may have about this. More information about this will be available on the council's website and social media channels shortly.

Bracknell Forest Council's executive

Cllr Mary Temperton, Leader

Having joined the Labour party at the age of 16, Mary spent her working life as a science teacher. Mary became a borough councillor in 2011 and has been on Bracknell Town Council for over 40 years. She led the party to victory in the 2023 local elections after over 20 years of a Conservative administration.



Mary is resolute about climate change and has made it a top priority for the council, taking it into her portfolio area alongside council strategy.

Mary is passionate about education and ensuring every child matters. She is prioritising provision for our youth and focussing on tackling the issues with SEND provision.

Cllr Dr Roy Bailey, executive member for children, young people and learning

Now retired, Roy is a former Thames Valley police officer, with extensive experience in a range of roles, including CID, drug squad, community and race relations and senior command. In his final role as head of training, Roy qualified as a teacher at Surrey University, where he gained a PGCE.



Roy subsequently taught sociology at both Farnborough Sixth Form College and Buckinghamshire New University. Following that brief teaching spell, Roy became a business consultant for Oracle, eventually becoming a programme director for executive sponsorship.

An active local politician, Roy has previously been a councillor for both Bracknell Forest Council and Bracknell Town Council. He is chair of the Bracknell Forest Constituency Labour Party, a position he has held for several years. Roy has been a school governor in Bracknell for over 30 years, including chair of one school for several years.

Roy holds a doctorate in criminal justice, and he is a regular contributor to academic journals on policing related issues, especially around governance. He writes regular blogs on policing for Policing Commentary, of which he is a founder member.

In addition to his role as a local councillor, Roy is a carer for his wife and proud grandad to his two grandsons.

Cllr Megan Wright, executive member of adult services, health and housing

Megan has a degree in nursing and worked in intensive care for 12 years. In 2009 she moved to Kenya for four years with her family and set up a charity called Tushinde. This was her full-time job until 2022. To date, Tushinde has grown to 25 staff and has directly helped over 1,000 children and thousands more indirectly through community projects. She is currently finishing handing it over to the management in Nairobi.



Megan had returned to the NHS at the start of 2023 and intended to resume her nursing career when she was elected to the council.

She is borough and town councillor for the Town Centre and The Parks. She sits on several committees and is the chair of the health and wellbeing board.

Cllr Paul Bidwell, executive member for economic development and regeneration

Initially from an IT background, Paul has held many senior positions in the private sector and has worked in the US (World Trade Centre) and Europe. He has worked for many international corporations, typically providing services into local government including adult services. He ran his own consultancy allowing him to understand the local SME landscape before returning to programme management,



this time within the security sector for an international renowned risk management organisation. He is a school governor at Fox Hill Primary School as well as chair of Age Concern Bracknell Forest.

He has been a town councillor since 2015 and borough councillor since 2021, for Easthampstead and Wildridings. He is a board member of the Cambian Partnership Joint Venture between the council and Countryside Properties and is on the board of the Bracknell Business Improvement District (BID), as well as being chair of the town centre regeneration committee and a member of the economic supplier development partnership.

Cllr Helen Purnell, executive member for environment and community cohesion

Helen first joined the Labour Party when she was 16 years old, believing in social equality and hoping for a fairer, kinder society.

She obtained a degree in history from Southampton University and a few years after graduating, joined Thames Valley Police, serving as a constable for almost 10 years and qualifying as a detective. She worked on various units, including the domestic violence unit, prisoner intervention, and local priority crime, investigating burglaries and robberies.

Helen is one of the elected Labour councillors for Easthampstead and Wildridings. She is on the licensing and safety committee, the climate change council sector group, disability and access advisory panel and is the Homestart representative.

Cllr Iksandar Jefferies, executive member for culture, delivery and public protection

Iskandar started his professional career on the frontline in the private security sector and worked



his way up to his current role overseeing Europe, the Middle East and Africa as a risk management professional. He has held board positions with international security industry bodies for diversity, equity and inclusion and young professionals respectively. Currently he is advisor to the board of directors for the International Foundation for Protect Officers. He has always had a passion for volunteering and empowering the next generation to success. He was honoured to be awarded the Freedom of the City of London in 2019.

Elected in May 2023; in his current capacity, Iskandar holds the positions councillor for Bracknell Town Council and Bracknell Forest Council respectively.

Iskandar and his wife moved to Bracknell 15 years ago as they wanted to raise their three young daughters in an area that was built for families. They have seen a lot of change since, and his vision is to ensure Bracknell Forest remains a place for families to live, grow and call home.

Cllr Guy Gillbe, executive member for planning and transport

With a background in operations for the charity sector, Guy was elected to Bracknell Forest Council in May 2023. Guy has spent most of his life in the borough, first in Sandhurst, then Bracknell. As a regular bus user, Guy is keen to make sure we always look beyond cars as the only means of transportation. He also serves as chair of the council's licensing and safety committee. He enjoys spending his free time making use of the borough's many ramble routes and walkways.



Cllr Kathryn Neil, executive member for finance and business change (deputy leader of the council and vice-chair of the executive)

Kathryn has lived and worked in Bracknell for a number of years. She has worked in the retail industry for over 15 years, including customer facing and head office roles and is now a branch manager. She has also held project and change management roles, including business change manager for Bracknell Forest Council in the transformation team.



Housing allocation policy consultation

Residents are being asked for their views on the council's proposed new housing allocation policy.

The housing allocations policy sets out who qualifies to join the housing register for social housing, how they can apply, how their application will be assessed and how their priority for rehousing will be determined. The current policy was drafted in 2016 with a minor update in 2021.

Demand for social housing in the borough is high and increasing. In April 2023, 1,900 households were on the housing register in the borough, this is an increase of more than 550 households compared to just three years ago. Over the same period, the number of homes available to let has steadily declined. The shortage of larger family homes is a particular issue with overcrowded households waiting many years to be rehoused.

The housing service is committed to developing a new housing allocations policy which provides a fair, transparent, and easily understood approach to meeting the housing needs of the local area.

The new policy will:

- make best use of the properties available for allocation and prioritise those in greatest housing need
- reduce waiting times for the most overcrowded households
- support key groups such as care leavers by ensuring their housing needs are recognised

- take account of legislative changes, such as the Homelessness Reduction Act 2017, to ensure it is supporting work to prevent households from becoming homeless

Cllr Megan Wright, executive member for adult services, health and housing, said: "The new housing allocation policy is needed to ensure the right people are receiving the right housing. It will also help to address the shortage in larger family homes for social and affordable rent in the borough, ensuring the most overcrowded households with dependent children are prioritised for these homes.

"By focusing on this group, we aim to reduce rehousing times for families living in unsuitable and overcrowded accommodation, which are currently much longer than for one and two bedroom properties.

"It will also allow us to give adequate recognition to the needs of groups, such as care leavers, foster carers, ex and serving armed forces personnel. We hope our residents will get involved with the consultation to ensure their views are heard."

Working together to tackle climate change

Earlier this year, the council joined forces with local businesses, schools and community groups to take part in the first Bracknell Forest Council climate change summit.

Over 130 representatives from across those areas attended to learn about the current climate situation in Bracknell Forest and discuss how groups can work together with the council to make progress on climate change.

Following the summit, the Bracknell Forest Joint Climate Action Board was formed. The board consists of representatives from local businesses, schools, community groups, parish and town councils, as well as Bracknell Forest Council officers and councillors. They will play a key role in creating and



implementing the new Bracknell Forest community climate emergency strategy, an essential requirement following the council motion to reach net zero as close to 2030 as possible, which was passed in September.

Moving forward, the board will be supported by working groups representing specific sectors within the borough. Each working group (aside from those for councillors and council officers) is being led by an organisation external to the council and will

select two representatives to attend future board meetings.

Beware of loan sharks

Before you borrow money, find out how to avoid loan sharks. If you can answer yes to one or more of these questions, you might be borrowing from a loan shark:

- Did they offer you a cash loan?
- Did you not receive any paperwork?
- Did they add huge amounts of interest or APR to your loan?
- Have they threatened you?
- Are you scared of people finding out?
- Have they taken your bank card, benefit card, passport, watch or other valuables from you?

Loan sharks can come in any shape and size. A recommendation from friends or family is the most common way to be introduced to an illegal money lender.

Loan sharks don't always use violence to ensure payments but might use psychological manipulation, such as threatening to expose their lending to loved ones or constant messaging through social media.

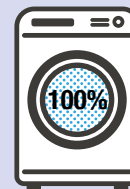

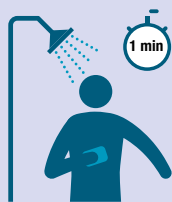
Avoid half loads when using the washing machine and dishwasher



Plan meals to make full use of oven space or use an air fryer or microwave instead

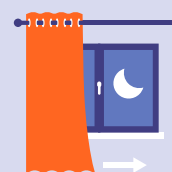

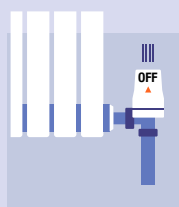
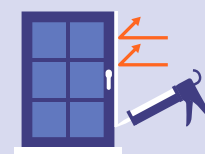

There are 10 different workout stations to try and features such as parallel bars and rings. These can be used for body weight exercises, known as calisthenics, to increase body strength, power and endurance.

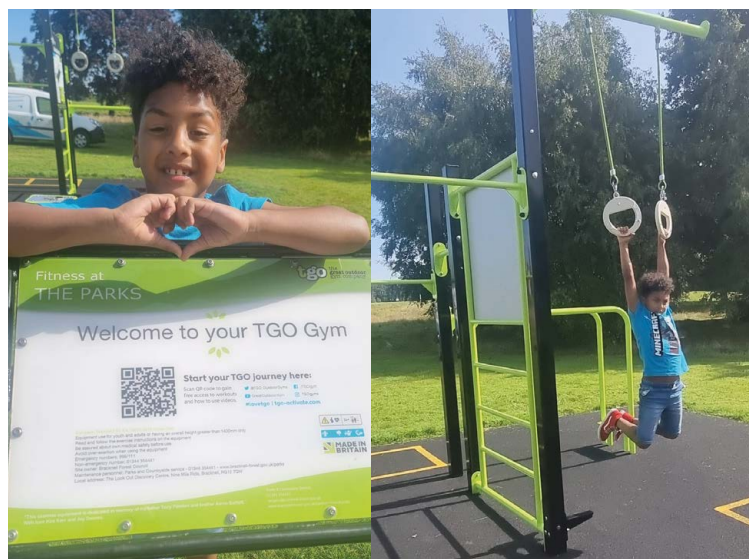

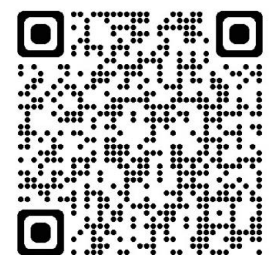

Blooming marvellous effort by volunteers

Council staff and volunteers planted thousands of wildflowers at Lily Hill Park this autumn.

50 TDK volunteers from across Europe were hosted by the local office TDK UK Limited, a business based in Bracknell. They joined our heritage parks team in September to carry out the work.

Their combined effort saw them planting 6,000 young wildflower plants in the lawn in front of the summer house. A further 6,000 wildflower plugs have since been planted thanks to the support of local volunteers.

A low flowering lawn plug mix was used containing 16 different wildflowers. Species such as cowslip, oxeye daisy, red clover and wild marjoram will add a splash of colour when they flower in spring and summer. They will also provide a source of nectar for important pollinators, such as bees and butterflies.

TDK donated funding towards the improvements. The rest was paid for using local development money allocated for improving suitable alternative natural greenspaces (SANGs).

The corporate volunteer event was organised through the Green & Active project, a campaign which promotes local green volunteering opportunities.

What are SANGs?

SANGs, or suitable alternative natural greenspaces, are recreational sites created and enhanced for people and wildlife.

There are 14 SANGs in Bracknell Forest, with examples including Cabbage Hill, Lily Hill Park, Peacock Meadows and Pope's Meadow. There are also grouped spaces, such as the Bullbrook Countryside Corridor.

These natural spaces provide attractive places for recreation away from the Thames Basin Heaths Special Protection Area (SPA). Reducing visitor numbers to the SPA will help to protect the internationally important ground nesting birds that live there.

Making improvements to SEND services



New autistic spectrum condition school

In September we announced that, following the successful bid for funding to build a new autism spectrum condition (ASC) school, a site has been confirmed. Having considered a number of sites throughout the borough, the council's executive agreed that the school site at Buckler's Park is the preferred location.

The site at Buckler's Park, where freehold land would be made available by CALA Homes, allows for construction to start as soon as planning and design have been finalised, making it the most time and cost-effective option.

The new ASC school will accommodate 100 pupils from reception to year 13, with the site providing indoor and outdoor teaching spaces. It is anticipated that the school will be ready to welcome pupils in September 2026.

Written Statement of Action

The new school is just one area of improvement for the special educational needs and disabilities (SEND) service. As part of the written statement of action (WSOA), following the Ofsted inspection of SEND provision in 2021, the council holds regular review meetings with the Department for Education (DfE) and NHS England.

The DfE and NHS officials have been complementary of the progress being made to SEND services for our young people and their families.

Feedback from government education experts on improvements to the borough's SEND services for children has been overwhelmingly positive – acknowledging many changes are being made quickly and for the better.

The new SEND strategy 2023-26 was published in June 2023. DfE officials commended this, having heard positive feedback from schools and parents on their involvement in the development of it.

It was also highlighted that a number of new staff had been recruited, with all posts within the new SEND structure now filled. A robust induction system is in place for new staff and the new leadership team is implementing improvements to all processes. A focus on improving communication is beginning to have an impact.

The improvements have also seen an increased focus on mediation, a new approach to Education, Health and Care plan (EHCP) assessments and a focus on upgrading systems, which has improved the quality and timeliness of assessments. It was noted that there is also a much more efficient use of Kennel Lane School places, with most vacant places being filled by Bracknell Forest children.

Families have reported that short breaks support is much better and communications with children has improved.

Within the Integrated Care Board (ICB), there is an apprenticeship role available for a young person to support the youth board. The next step planned is to develop a SEND youth forum.

From a health perspective, waiting times for occupational therapy (OT) services have continued to reduce since the last review meeting. Waiting times for triage for most children and young people referred to the OT service is now down to two weeks. There has also been a reduction in the number of children and young people awaiting a sensory processing workshop, with positive feedback from families in relation to the triaging process.

Since the last review meeting, the new approaching adulthood policy has been completed and uploaded to the local offer website, which young people and their families can access. A preparation for adulthood senior member of staff has joined the council recently and work will continue with a focus on ensuring a positive impact for children and young people.

School leaders, including headteachers, provided positive feedback about the changes that have taken place, and in particular their involvement in developing the new SEND strategy. They provided constructive feedback around the need to develop a new specialist school, which is currently being progressed, and that while improvements were being felt, it would take time to feel the full impact of all the changes.

Cllr Roy Bailey, executive member for children, young people and learning, said: "Improving services and opportunities for children and young people with SEND is a key priority. The feedback from the DfE is positive to read and we will continue to ensure this progress is maintained."

Victoria Stageman, chair of the Bracknell Parent Carer Forum, said: "We have been working closely with Bracknell Forest Council and we are starting to work more closely with the ICB. We have built positive relationships within both. Co-production is becoming embedded in many of the projects we are working on. We are able to provide appropriate challenge and feel we are listened to and the opinions of our members matter. As a Parent Carer Forum, we can see the improvements coming and parent carers are starting to give more positive feedback."

Grainne Siggins, executive director for people, said: "We are pleased to receive this positive feedback from the DfE, an acknowledgment that progress is being made with our SEND provision. However, we know there is still more work to be done. While we have completed 81 of the 113 actions of the WSOA, we continue to work to address those that have been delayed due to recruitment and process issues. We can assure parents and carers that we remain focussed on delivering the best possible provision for our children and young people."

Upcoming changes to childcare support

The financial support available to parents to help with the cost of childcare is increasing, to make it easier to move into or take on more paid work.

Starting from April 2024, existing childcare support will be expanded in phases. By September 2025, most working families with children under the age of five will be entitled to 30 hours of childcare support.

This is based on childcare for 38 weeks of the year (school term time). You may be able to use fewer hours per week for up to 52 weeks. Check if this is something your childcare provider offers.

There are 570 funded hours available per year if eligible for 15 hours and 1,140 funded hours if eligible for 30 hours.

You must apply the term before your child turns nine months, two years or three years. Funding begins the term after they turn nine months, two years or three years.

You can use tax-free childcare or Universal Credit for childcare at the same time as this offer.

Update on The Deck redevelopment



Developers have announced that plans for The Deck redevelopment in Bracknell town centre cannot go ahead as originally planned.

However, they have assured residents they are already developing fresh new plans for the site, which formally housed the Bentalls department store.

In the interim, Bracknell Regeneration Partnership (BRP) and the council are considering what could go on the site while permanent plans are developed.

BRP, which owns the land, said substantial rises in construction costs, the effects of inflation and the change in market conditions post pandemic had made the original plans unviable.

Tom Woolven, asset manager for BRP, said: "This is not the end of the road for the area that The Deck was due to occupy, and we now have an opportunity to look at alternative proposals for the site that respond to the changing needs of the local community and

help contribute to an already thriving town centre.

"We are already researching and developing new plans. It is early days for this major rethink, but we will be able to share clearer ideas in due course, with the ambition to prepare a fresh planning application.

"We will also be working with our partners at Bracknell Forest Council to consider a range of temporary uses that will allow us to utilise the space whilst longer term plans are developed."

While the site is not owned or managed by the council, it is committed to working with BRP to see what could go in the site temporarily and permanently for the benefit of the community.

Cllr Paul Bidwell, executive member for economic development and regeneration, said: "We know that residents will be disappointed that The Deck cannot progress in the form that was agreed back in 2019.

"However, the world has changed significantly since then and BRP is clear that the development, in the original guise, isn't financially viable given rising costs and the

impact of unforeseen global events.

"What this does allow for is completely re-imagining how that site will be developed in line with current and predicted local shopping, leisure and market trends and needs.

"BRP is already researching and developing plans for the site and, in the interim, we are very keen to support it being used for the benefit of the local community – using it as a meanwhile space for temporary activities and events.

"We are committed to getting this site regenerated – it is a key part of our town centre redevelopment – and we will work with our partners to ensure what is taken forward is viable and reflects what the local community needs and would like to see in the town centre."

As winter rolls on, staff in our highways team and our contractors, Ringway Infrastructure Services, have been preparing for the cold nights ahead. Our gritting service is a vital part of our winter weather plan, keeping our roads, footpaths, and most importantly, our residents safe. The team often works around the clock, to ensure the borough keeps moving throughout the colder months.

Did you know?

- Our contractor, Ringway, has three gritters with eight drivers working on a rota basis.
- Over the summer months, Ringway calibrated and serviced all gritters and associated plant and equipment and replenished the salt barn with fresh salt stock.
- We have three primary routes covering approximately 178km of roads and 56km of secondary routes.
- There are 78 salt bins throughout the borough.
- We started the gritting season with 1,500 tonnes of rock salt in storage ready for the months ahead.
- We use pre-wetted salt - a mixture of salt and brine.
- Last winter, gritters salted routes 69 times using 962 tonnes of salt.
- It takes around an hour to get a gritting truck ready to go out.
- It takes around three hours to treat primary routes.
- In severe conditions, the gritters go out up to four times per day.
- Salt works by lowering the freezing temperature of water and requires the action of cars driving over it to turn it into solution.
- Salt becomes less effective below minus seven degrees centigrade.
- Salt cannot stop water freezing if temperatures fall below minus 10 degrees centigrade.
- During times of snow, our grounds maintenance contractor, Continental Landscapes, helps with clearing snow from roads and public footpaths.
- Our heaviest truck weighs around 26 tonnes when fully loaded—so in severe conditions, it's not always safe or possible for gritters to navigate smaller streets.
- If road users park their vehicles without due care and consideration, there's every chance the gritter won't be able to access the road to treat it.

Cllr Guy Gillbe, executive member for planning and transport said: "Our highways team is extremely busy in winter months, working hard to keep our roads and footpaths safe for residents. During periods of snow, we treat the busiest roads in our area first. It takes around three hours to get round this network and when this is complete, should the need arise, we begin to treat secondary roads.

"We kindly ask residents to show patience and understanding during times of bad weather. Please take extra care if you are walking or driving in snow and icy conditions and remember to show due care to other road users. Please show consideration when parking, to allow enough room for larger heavy vehicles, such as the emergency services, gritting lorries and waste collection lorries to be able to drive safely in icy conditions.

"The following advice may help:

- be aware of the local forecast and road conditions by listening to the radio, watching TV or using the internet
- generally, the mainstream media issues air temperatures which may be several degrees higher than surface temperatures where ice forms
- take precautions to grit and clear your own paths and driveways
- clear snow from your car before driving
- get your own salt supplies in advance - these are often available from garden centres and supermarkets - but do not leave it too late
- be a good neighbour and check on the elderly and vulnerable who may need your support during snowy periods, as they may not be able to get to the shops or collect medication."

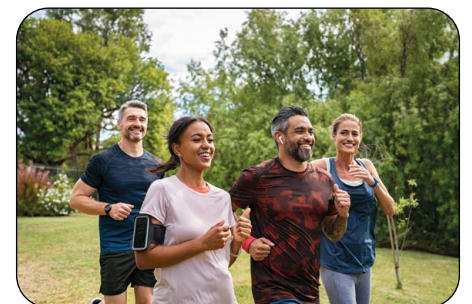

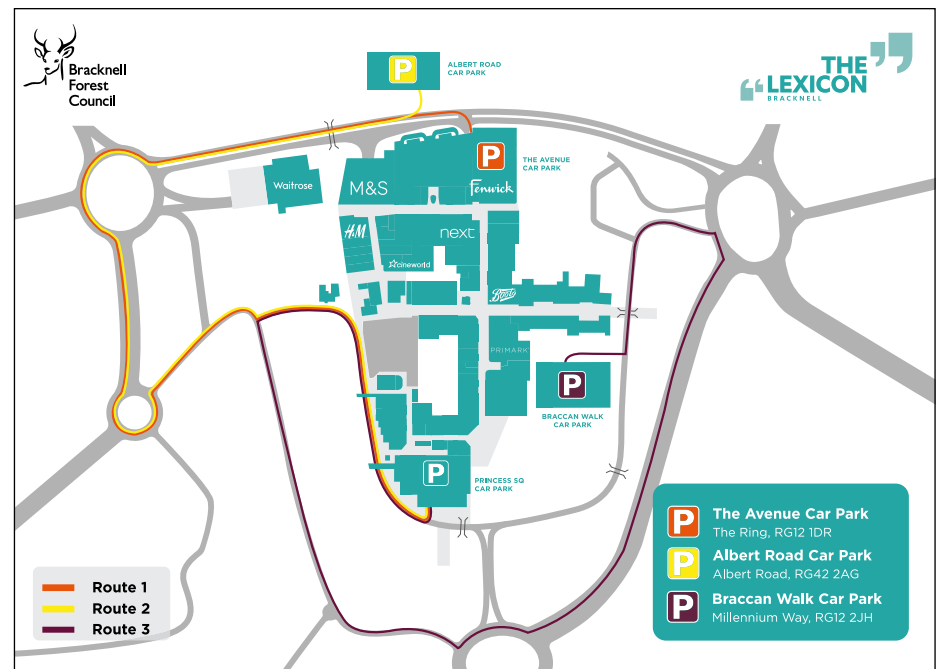

Sleigh your Christmas waste and recycling



Compared to the rest of the year, we produce 30 per cent more waste at Christmas in the UK. Here are a few things you can do to keep control of your waste.

Cllr Helen Purnell, executive member for environment and community cohesion, said:

“With the extra amount of waste we create at Christmas, what better time to knuckle down on your recycling efforts? One of the biggest issues we still face is food waste. By only buying what you need and using any leftovers, we should be able to minimise the amount of food we are wasting. If you do have bits that need to be disposed of, make the most of our food waste recycling service and we can turn it into something useful, like energy or fertiliser.

“We often use a lot more paper at Christmas, so make sure you do the scrunch test and if it stays in a scrunched ball, recycle it in your blue bin. You could even choose to wrap your presents in cloth and eliminate paper completely. There are lots of alternatives to have a more sustainable Christmas.

“Let’s keep up the momentum and not let our standards slip over the festive season.”



Christmas cards - why not make your own cards this year using old recyclable materials? Avoid using any ribbons, glitter or bows that can't be recycled. Hold onto this year's Christmas cards and reuse them as tags or cards for next year.



Empty glass bottles - These can be recycled at your local bottle bank, or at Longshot Lane or Smallmead recycling centres. Glass bottles no longer need to be separated by colour, you can mix it up and they will be collected.



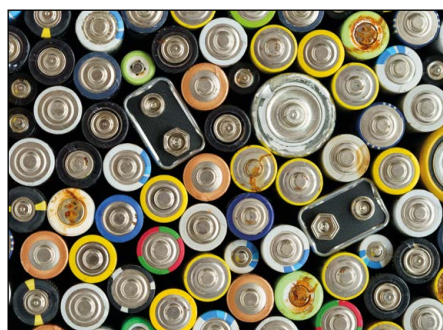
Wrapping paper - Double check that every part of your present wrapping is recyclable before putting it in your blue bin. Remove all sticky tape and embellishments. Wrapping paper must be non-foil to be accepted, do the scrunch test to make sure. If you scrunch it and it remains in place, then it's OK to recycle.



Food waste - In order to prevent food waste, only buy the amount of food you need. Love Food Hate Waste has a portion calculator that can help. Leftovers can be frozen and reused at a later date, or anything that can't be reused can be disposed of in your food waste caddy.



Packaging - Delivery boxes should be broken down and recycled. Bubble wrap and plastic film cannot be recycled in your blue bin but can be taken to your local carrier bag collection point at the supermarket.



Batteries and electricals - These should not be disposed of at home. They should be taken to your nearest recycling point. Household batteries can be taken to most large supermarkets and also our local recycling centres.

Christmas and New Year collection changes

Collections will continue as normal up to and including 22 December.

Any trees not in a closed brown bin/council garden waste sack, or sacks that have not been booked will not be taken.
