President's Report

Dr Fiona McIntosh



It gives me great pleasure to report on behalf of the ISS Australia Board of Directors on another successful year at ISS Australia. ISS Australia has come out of the global COVID19 Pandemic in a strong position operationally and we maintain the depth and breadth of our core social work, legal and family mediation services across borders.

The board has had another busy year with the finalisation of selling ISS Australia's Flinders Lane property (which in the post-pandemic period was no longer serving our best interests) and reinvesting the proceeds into a suitable investment vehicle. This has given ISS Australia more contingency and flexibility and more certainty into the future around our financial position. Thanks to our CEO, Peter van Vliet, and our Treasurer, Richard Giles, for leading this piece of work successfully with our Board.

Working with management we have also approved and established a strengthened stand-alone International Family Mediation service as well as supporting the finalisation of planning around a new counselling service, both of which are planned to operate on a modest fee-for-service basis. These services will compliment our existing International Parental Child Abduction legal and social work services and our international child protection services which are funded by government.

At the end of the financial year the board finalised a significant piece of work around improving the employee value proposition at ISS Australia after this area was identified as one needing improvement. This was a complex piece of work around strengthened employee benefits and staff engagement and I am pleased that ISS Australia now offers a more attractive proposition for our staff in this area.

Another pleasing development over the last few months has been the establishment of a closer working relationship, through an exchange of letters, with Child

Rights International, an Australian based non-government organisation, headed by the Honourable Jennifer Coate AO. Our two organisations share similar goals and values and the partnership can only benefit us and our clients.

As always, I would like to thank our terrific staff for their hard work and dedication to assisting children and families across borders. Our staff are the lifeblood of our organisation and our professional social workers, lawyers and mediators give their all to assisting our clients who are often in the most complex and difficult of circumstances.

I give special mention to our management team, Damon Martin, Kay Hardefeldt, Jessica Raffal, Ann Freilich and our CEO, Peter van Vliet, for their hard work. I would also like to thank Damon Martin who acted as CEO for part of 2022 while Peter served briefly in Canberra.

Finally, I would like to thank the dedicated and committee individuals who form our board for their hard work in governing our organisation effectively. I would also like to pay tribute to Rebecca Cowan, Executive Director of the Good Friday Appeal, who left the board in July 2023 after five years of invaluable service.

Next year in October ISS celebrates its 100th birthday as the organisation was formed in 1924 in Geneva, Switzerland. ISS is now a truly international network with members in around 130 countries providing vital international services to children and families across borders. I look forward to the opportunity of celebrating with you all next year.

CEO's Report

It's been another busy year at ISS Australia, as the world has emerged from the COVID-19 pandemic and international travel and movement began to return to normal levels. ISS Australia's key services continue to be delivered in a highly professional way and our clients continue to give us excellent survey results which is not surprising given the incredible depth and experience of our frontline staff.

I would like to thank Damon Martin, our Deputy CEO, who acted as CEO while I was working briefly in Canberra in the first quarter of the financial year. Our management team continues to drive excellence at ISS Australia and I also give particular thanks to our new Managing Lawyer, Jessica Raffal, our Social Work Manager, Kay Hardefeldt, and again Damon Martin for his key role in managing our NSW government funded services and also for his significant contribution to the ISS network internationally.

Special thanks also to Eleni Bailey who acted as Manager Social Work and International Family Mediation, while Kay Hardefeldt was on parental leave. Eleni Bailey has now moved on to coordinating our new stand-alone International Family Mediation Service and is driving continued improvement and growth in that space. Ann Freilich has also continued to provide excellent accounting services during a challenging period financially.

Our caseload continues to be busy and last but not least I have to thank our highly talented and committed social work, legal and mediation staff who perform their critical work in assisting children and families across borders every day. While many of their stories and successes cannot be publicly shared because they are so deeply personal – I can attest that the work they do is simply incredible, often very moving in terms of outcomes and of course critical to our client's well-being. Thank you all!

A priority in 2022-23 was in growing our organisation and we focused on expanding our service offer in two areas: International Family Mediation; and Counselling. Feray Ergun and then Eleni Bailey have been critical in establishing our new stand-alone International Family Mediation service, building on the great work of Kay Hardefeldt earlier.

ISS Australia now offers a comprehensive, stand-alone International Family Mediation service, including legally assisted mediation when required, and focusing on the best interests of the child. International Family Mediation

can be a valuable alternative to lengthy and costly court proceedings and is an important tool in resolving international parenting arrangements.

We were privileged to have her Honour, Justice Victoria Bennett AO, speak at the relaunch of our International Family Mediation service earlier this year. I would also particularly like to thank the Felton Bequest and Equity Trustees for their continued invaluable support of our IFM service.

Our new counselling service is close to being finalised following Board approval and thanks to Lizzie Gray for the invaluable work she has done setting up the service model and implementing the training required to launch this new service.

With regards to ISS Australia's core funded services in international parental child abduction (legal and social work); international child protection; special search; and post adoption tracing services, ISS Australia continues to provide a high level of service to our clients through our professional staff again with excellent client survey results. We particularly thank the Commonwealth and New South Wales Governments for their on-going invaluable support of ISS Australia here.

ISS Australia's staff and our board President had the opportunity to meet in February, 2023, and set some important markers for the year ahead. After the challenging years of COVID lockdowns it was wonderful to meet inperson and build trust, cohesion and sense of purpose in the team. Of particular note was staff and board interest in improving the employee value proposition at ISS Australia, which lead to further staff and board consultations and a significantly improved staff benefits package for ISS Australia employees. I thank staff and the board for their valuable contribution here and we are all pleased ISS Australia has strengthened its support for staff and is now more competitive against industry standards regarding employee benefits.

The February conference also looked at staff well-being and vicarious trauma which will continue to be a focus as we come out of the pandemic and deal with some of the mental health challenges stemming from that period. Our style of work has clearly changed following the pandemic with greater flexibility which is of great benefit to staff and particularly for those with caring responsibilities. ISS Australia has embraced this change while also seeking new ways of keeping our teams, who are now spread across all of Australia's major cities, connected and engaged.

ISS Australia continues to strengthen our governance frameworks and more recently we have strengthened our policies around preventing sexual harassment, exploitation and abuse (SHEA) to be at the forefront of international standards in this area, noting our particular role in supporting, sometimes vulnerable, children and families.

ISS Australia continues to contribute to our international network and has assisted in developing policies internationally in areas like international kinship care and family violence across borders. We value highly our role in the international network and the benefits it brings for our cross-border clients which is our unique proposition. We thank in particular our General Secretary, Jean Ayoub, and our partner agencies around the world for the cooperative and reciprocal dealings that underpin the mission of our network globally.

We remain active and engaged in policies around our work in areas like international kinship care, family violence across borders, and assistance and greater recognition and support for intercountry adoptees. We congratulate governments on continuing to drive reforms in these areas noting there is always more to be done.

I wanted to also thank some individuals who have assisted ISS Australia this year including: our very own Ambassador Felicity Gerry KC who has driven strong relations with the Deakin University law school Australia and ISS Australia; Maurice Edwards has been very active with us in leading our commercial partnership with Kate Rafton and the team at Rafton Family Lawyers; Jennifer Coate AO who has played an active role presenting to our organisation and also strengthening the engagement between ISS Australia and

Children's Rights International; and K&L Gates Lawyers have also provided invaluable pro-bono legal assistance to ISS Australia over the past year. I would also like to congratulate Jacqueline Pascarl OAM who joined the ISS (International) Governing Board this year and brings her great knowledge and experience in our operating areas to this role. I would also like to thank Breanna Worthington who continues to provide invaluable and highly skilled voluntary support to ISS Australia in the marketing and promotions area. Thank you all!

I would like to thank our former employees who have moved on recently including just recently one of our longest serving and leading social workers, Phoebe Lewis, earlier two of our leading lawyers Belinda Li and Jenny Tam, and also the talented Feray Ergun who has worked with the organisation twice over several decades. Thank you all for your contribution and thanks also to others who have moved through the organisation in recent years.

Last of all I would like to thank the ISS Australia Board for their work in ensuring our organisation is properly governed and maintains a strong strategic focus. In particular I would like to thank our Board executive, being our President, Dr Fiona McIntosh, our Deputy President, Nina Brooks, and our Treasurer, Richard Giles, who have all done an incredible job and given away countless hours of their personal time in supporting our organisation. Their smooth handling of a major asset sale and the further reinvestment will ensure ISS Australia has financial certainty in the decades to come and is to be applauded.

ISS Australia looks forward to the years ahead as we continue to meet the challenges and opportunities confronting us. As the organisation approaches 100 years internationally next year it gives us time to pause and reflect that we are all just individuals moving through the organisation and contributing to its greater purpose. I think in particular of two former stalwarts and leaders of ISS Australia, David Cox AO and Merle Mitchell OAM, who both passed away in recent times. Vale! We remain absolutely committed to supporting children and families across borders and continuing to strengthen and grow our mission and role in this area.

We have implemented our Reconciliation Action Plan and remain committed to reconciliation and supporting first Australians and their enduring sovereignty which has never ceased and was never ceded.

International Parental **Child Abduction Service**

Service Annual Report

The International Parental Child Abduction (IPCA) Service has 29 years of experience in supporting families affected by International Parental Child Abduction. It comprises **Legal and Social Support Services that work together** to provide wraparound support to clients experiencing IPCA.

This collaborative practice ensures that clients' legal, emotional and practical needs are met during an extraordinarily challenging and traumatic period.

The IPCA service draws upon its extensive experience in this highly specialised practice area to deliver high quality casework services, diverse and engaging community education. There is also expert consultation to professional organisations and associations and the development of highly valuable and accessible resources on all aspects of IPCA.

Casework Services

The IPCA Service provides accessible support for individuals, families, and professionals through our national telephone helpline, strong web presence, and integrated referral and booking systems. The IPCA service is highly responsive; clients can receive rapid advice or assistance, often on the same day in urgent cases, ensuring that stress and further complications can be minimised.

In 2023, the IPCA Service provided support to 202 case files and 634 inquiries involving children taken to more than 125 different countries.

The overwhelming majority of case files involved cases in which children had been abducted outside of Australia by a parent. Most Legal cases involved submitting applications for the return of those children under the 1980 Haque Convention. Most Social Support cases involved intensive counselling, case management, and referrals to local and international support services. When a risk of harm to self or others is identified, the Social Support Service worked in parallel with the legal process to address safety concerns.

The countries most represented in IPCA cases and inquiries were New Zealand, the United Kingdom, the United States, Canada, India, Lebanon and Germany.

The Legal Service finalised 69 case files and provided advice or limited assistance in an additional 439 matters. The Social Support Service provided support in 133 case files and

advice or limited assistance in an additional 195 matters.

The IPCA Service has unique access to the ISS global network, spanning over 140 different countries. This places the IPCA Service in a strong position to support families affected by IPCA in both 1980 Hague and Non-Hague convention countries. Using the ISS global network, the IPCA service can provide cross-border case management and referrals to facilitate access to critical support for children and parents in Australia and abroad.

In 2023, referral and case management with overseas ISS network members involved at least 80 internationally abducted children. Further, our cross-border case management and referrals have worked to;

- Ensure safety by making overseas child protection reports, requesting health and welfare checks, and providing referrals to support services
- Reduce parental conflict by providing practical and emotional support and helping parents focus on the needs of their children
- Reduce the negative impacts of IPCA by opening international communication channels between parents and their children

NSW Government **Funded Services**



Intercountry Casework Project:

The ISS Australia Intercountry Casework Project assists Australian Child Protection Authorities and Out-of-Home Care providers with the international element of their casework. This includes providing thorough background checks of prospective carers, exploration and facilitation of family connections and conducting assessments of extended family placement options overseas.

There are over 46,000 children in Out-of-Home care in Australia, and almost half of these children are cared for by people whom they are not related to. When a child cannot be cared for by their parents, the preferred means of care should be within their extended family (provided it is safe to do so), regardless of whether the extended family resides overseas. Exploration of family placements both locally and overseas provide the best opportunity for a child to be raised with a strong sense of identity, belonging, roots and culture.

An International Kinship Care video developed by ISS Australia in 2022 has been a powerful resource in influencing child protection caseworkers about this important and viable alternative care option for children in care. The International Social Service global network of members in 132 countries can help Child Protection Authorities fully explore overseas family and kinship placement options when a child can no longer be cared for by their parents.

International Post Adoption Tracing Service (IPATS):

IPATS provides free tracing and reunion support to NSW residents who have been separated by adoption, and where one party is thought to be overseas. The majority of our cases involve searching in the UK and New Zealand, which highlights the widespread past adoption practices in Britain and the Commonwealth, as well as the significant English and New Zealand population in Australia. Similarly, many of our clients were adopted in Australia and are searching for family members overseas which is evidence of Australia's diverse and multicultural population.

On 21 March 2023, Damon Martin presented at the Rafton Family Lawyers Reflections in Law Conference in Orange. The session was titled 'Adoption, Surrogacy and Immigration - Modern Families in the Land Downunder'. Damon discussed Australia's previous shameful adoption history which was characterised by secrecy and the 'clean-break theory'. Damon presented on how practice has evolved over time to embrace the spirit of openness. Coincidently, the presentation occurred on the 10th Anniversary of the Federal Apology for Forced Adoption practices. ISS Australia supports clients impacted by former forced adoption practices, many of whom endure a lifetime struggle with trauma, guilt, attachment and identity issues.

NSW Special Search Service:

In 2023, ISS Australia's NSW Special Search Service completed its fifth year of achieving life-changing outcomes for our clients. The service provides free and specialised search and reunion services to people separated by NSW Government intervention. In 2022 – 23, 78% of our cases related to searches for people affected by adoption, while 22% related to Care Leavers (such as children who were placed in institutional and other forms of Out-of-Home Care). Our 63% success rate of locating and reuniting family members demonstrates our extensive search skills and ability to achieve great outcomes for our clients. Undoubtedly our greatest search tool is our access to LifeSearch, an online database of NSW Births Deaths and Marriages (BDM) records.

Staff Spotlight 2023

Charissa Chong



I started as a Lawyer in the legal service at ISS Australia in September 2022, and was appointed as Senior Lawyer in July 2023.

Prior to ISS, I began my career at Women's Legal Service NSW where I gained in-depth experience working primarily with women experiencing family violence and adult survivors of child sexual abuse. Later on, I ran the Health Justice Partnership between Inner Melbourne Community Legal and two adjacent tertiary hospitals - seeing patients at the hospitals and advising on a wide range of legal issues. From this work, I learnt how to work with people through some of the most traumatic times of their lives. It is, and continues to be, a privilege to earn a client's trust and be able to make a positive difference in their life.

The legal service at ISS is a community legal centre ('CLC'), albeit a specialist nationwide one. It has always been my first choice to work in CLCs. One value embodied by CLCs that I feel particularly strongly about is access to justice - anyone, regardless of background or socio-economic status should have access to high quality legal advice and assistance. At ISS, we strive to provide this every day.

I was drawn to the role at ISS for two reasons. First, I was certain that the complex, transnational nature of the work would be interesting (and it is!); and second, I valued the opportunity to be able to work collaboratively with the social work team. Coming onboard ISS, in many ways, felt like coming home, especially after the extended time away from work I had taken to raise my young family. It was a challenging period of transition, but my manager and senior staff were nothing but supportive and I quickly felt part of the ISS Australia family. I cannot overstate how instrumental the support from both my workplace and my family were in giving me the confidence to thrive in this new phase of my life.

A typical day at ISS includes advising new clients who contact us for legal advice and working on active casework. Clients come to us in all situations related to international parental child abduction ('IPCA'). Most often we speak to a parent whose child has been wrongfully removed to or retained in an overseas country; but we also advise parents who are contemplating removal, preventing removal, or affected in some other way by IPCA. In terms of active casework, we most commonly assist parents in Australia with making return or access applications under the 1980 Hague Convention with respect to their children who are overseas. This involves preparing an application and an affidavit in support of that application. The affidavit is a comprehensive document that tells the court the client's story, and a welldrafted affidavit is imperative to any application. A love of drafting and the skills to accompany it are a must in this role.

One of my favourite parts of active casework, however, is

the opportunity to connect and learn from lawyers around the world, specifically in the overseas countries where the applications we prepare are filed in. Applications under the 1980 Hague Convention can be procedurally complex, passing through multiple hands (lawyers and the Central Authorities) before being filed in the overseas country. Once filed overseas, lawyers in the overseas country are often appointed to represent the client. As the legal service at ISS Australia is the first point of contact in the client's journey, it is common for the overseas lawyer to liaise with us about the client's case. For the overseas lawyer, they often want more information about the client's circumstances and how Australian law would operate in certain aspects of the client's case. In turn, it is a chance for us to learn how return cases are advanced specifically in the overseas country, what Hague judges in that country look out for, and the kind of orders the overseas court is likely to make in such applications. This process differs to some extent for every single country that is a signatory to the 1980 Hague Convention and it has been a fascinating journey to learn these differences.

It is truly special to be a part of this ISS Australia legal team. We are altogether six lawyers and paralegals spread across Australia, but we have managed to make working together in a virtual office productive and enjoyable. A highlight of our time together in the last year though has been the time spent together in-person as a team - first, at the Staff Day in February 2023 in Melbourne, and then in March 2023 when the lawyers attended the CLC Conference in Hobart. The Staff Day was a great morale booster - a chance for the whole organisation to come together and build bonds, learn, and grow together towards a common vision. Likewise, the CLC Conference in Hobart was just fantastic! International Family Mediation

International Social Service Australia's International Family Mediation (IFM) service has grown from strength to strength and continues to provide much needed support to families facing high-conflict cross-border parenting disputes.

The IFM service was launched as a stand-alone service on the 26th July 2023 at a memorable celebration in Melbourne. The Honourable Justice Victoria Jane Bennett AO was the guest speaker at the auspicious event. Our ISS Australia president Dr Fiona McIntosh and our CEO Peter van Vliet also spoke about the important service our Attorney General's Department accredited Family Dispute Resolution Practitioners provide to families around the world.

While ISS Australia has been providing IFM services for over 10 years, since 2012 it has always been an add-on to our other core services, provided by ISS Australia staff who have other roles within the organisation. Recognising both the past support from and now the generous further assistance of the Alfred Felton Bequest philanthropic funding in Victoria ISS Australia can now provide a dedicated IFM service. Ms Eleni Bailey as the IFM coordinator will manage the growth and development of the IFM service and with assistance from other accredited mediators facilitate mediation services across borders.

The ISS Australia IFM team carries out detailed risk assessments, pre-mediation screening interviews, determine suitability for family dispute resolution, and co-mediate family dispute resolution mediations where appropriate. The IFM team have also been trained in legally assisted mediations and where suitable, are now able to facilitate legally assisted mediations, always focusing on the developmental needs and welfare of the children. ISS Australia provides IFM for matters under the the Hague Convention on the Civil Aspects of International Child Abduction (1980) as well as for people wishing to resolve international parenting arrangements more generally. As per the Hague Guide to Good Practice on International mediations neutrality, impartiality, fairness guide our approach and does the best interests of the child, and incorporating the child's voice wherever appropriate guide our practice.

Our IFM service continues to facilitate productive discussions among separated families, focusing on the needs, welfare, and arrangements for their children. We firmly believe that creating a safe place, establishing respectful communication

guidelines, and fostering open dialogue and mutual understanding, can pave the way for sustainable and amicable solutions.

What distinguishes our IFM service from others is our participation in the extensive International Social Service (ISS) network. This network has members in over 130 countries which enables us to make timely child protection notifications where appropriate, managing risk and ensuring the safety and wellbeing of the children involved. Furthermore, we recognise the importance of providing in country support to the overseas parents who may be facing challenges and need additional referrals. Our international reach allows us to offer comprehensive assistance to these parents, ensuring they have access to the resources they need.

We firmly believe that every family deserves a chance to find common ground and build a brighter future, regardless of the geographical boundaries that may exist. The launch of our IFM service underscores our dedication to this belief and our determination to make a positive impact on families' lives.

Our **IFM website** has undergone a makeover with the addition of a frequently asked questions drop down menu, process tiles outlining step by step the mediation process, a statistic snapshot, and testimonials.



The proposed amendments to the family law act 1975 and the impact on relocation cases.

The Family Law Amendment Bill 2023 currently before Parliament proposes a number of changes to the Family Law Act 1975 and parenting arrangements for children.

The significant amendments proposed involve repealing the presumption that it is in the best interests of the child for the child's parents to have equal shared parental responsibility and also the related provisions requiring the Court to consider the time parents spend with their children, including equal time and substantial and significant time. If the proposed changes become law the Federal Circuit and Family Court of Australia would still be able to make Orders for equal shared parental responsibility and equal time but the presumption would be removed.

The draft Bill provides different factors to be taken into account when assessing the best interests of a child. Currently, a Court must consider a number of factors including two (2) primary considerations and thirteen (13) additional considerations. The Bill proposes five "simplified" factors for the Court to consider when assessing the best interest of a child in addition to a "catch all" factor. There is an additional best interest factor proposed for an Aboriginal or Torres Strait Islander child, that recognises the importance of a child staying connected with the child's culture, family, community, country and language.

Amendments also seek to codify the rule in the case of Rice & Asplund that final parenting orders remain in force unless the Court has considered whether there has been a significant change in circumstances since those final parenting orders.

The changes would empower the Court to make a "harmful proceedings order" prohibiting a party from instituting proceedings against the other party without leave of the Court.

Finally the Bill will make it a requirement, except in particular or exceptional circumstances, for Independent Children's Lawyers (ICLs) to meet with a child to make sure the child's views are considered. It also proposes removing the current requirement that ICLs are only appointed in exceptional circumstances in "Hague Child Abduction" matters.

Assuming these proposed amendments become law one might ask what are the implications for relocation matters?

After the Family Law Act 1975 came into effect in January 1976 the law regarding relocation was that the primary carer of the child was allowed to move freely, subject to what was in the best interest of the child. If there were valid reasons for the primary carer to relocate to another town, city or state, then provided that was also in the best interests of the child, the relocation request was ordered.

The decisions of the Court with regard to relocations changed significantly after the 2006 amendments to the Family Law Act, which introduced the presumption of equal shared parental responsibility, coupled with one of the primary consideration for best interests being that the child maintain a meaningful relationship with both parents.

For a number of years after the implementation of the Family Law Amendment (Shared Parental Responsibility) Act 2006 applications for relocation of a child to the Court were significantly more difficult as a result of those amendments in 2006 and Orders for Sole Parental Responsibility were not the porm

However in the last few years we have seen Judges less reluctant to make Orders for Sole Parental Responsibility, particularly in circumstances where there is high conflict between parents or significant issues with parents communicating. We have also seen a recent trend to allow a child to relocate with the child's primary carer to cities, states and even countries if it is also in the best interest of the child. The advances in technology allowing parents and a child to communicate more easily by Zoom and the Wattsapp and the various other social media platforms that are available has shifted the Court outcomes in favour of relocation.

The current proposed amendments to the Family Law Act, would appear to enhance this recent trend in favour of granting relocations if the best interests of the child can also be satisfied.

We will probably not get back to the law as it was in the late 1970's & 1980's where there was liberal freedom of movement of a child with the child's primary carer, but certainly these proposed amendments, if made law, would be a further retreat from the relocation decisions made 10-15 years ago and reflect more closely those made 25-30 years ago. As they say sometimes what is old is new again.
