OVERVIEW

We will endeavour to dispatch orders in the fastest possible time and in the order in which they are placed. We aim to deliver within 8 to 10 working days following confirmation of an order unless otherwise indicated in the delivery details of the applicable product. Though we aim to deliver within the communicated time frame, delivery may take longer due to unexpected events. In the unlikely event the delivery time exceeds 30 days, you may cancel your order.

SECTION 7 - RETURNS

Subject to the Terms, we guarantees a full refund for any returned items, provided that all items are returned in the same condition as they were when you received them.

You have 30 days after receipt to return an item unless it's damaged or noticeably used.

We offer free returns from the EU. If you live outside these countries, you are responsible for the associated return shipping charges.

Once we receive it, we will inspect your returned item.
