Terms and Conditions

for the cewas Start-Up Programme

Please read the competition terms and conditions carefully. By applying to the cewas Start-Up Programme (hereinafter referred to as "cewas"), each participant of the start-up programme (hereinafter referred to as "participant") acknowledges that he or she has thoroughly read these terms and conditions and agrees with them. cewas reserves the right to disqualify any entrants who breach the terms and conditions of participation.

These terms and conditions also apply to cewas coaches, Think Tank Members or partner organisations (hereinafter referred to as "Partners").

Participation conditions and eligibility

- Participants are expected to have a Bachelor or Master Degree. People without an appropriate
 degree may be permitted if they can prove an extended relevant work experience (decision by the
 cewas study committee). Further, cewas expects a strong motivation to contribute to the sustainable
 development of the sanitation, water and/or resource management sector at the national and
 international level, an entrepreneurial spirit and an excellent knowledge of English (oral & written).
 Participation will be decided upon in a common decision making process between cewas and the
 future participants.
- Projects in any development stage can apply to the programme whether it is only a vague idea or an up and running company with development needs.
- Participants can work individually or in a team. Cewas will consider the team in its entirety as an
 individual ("participant") and the leader of that team must conduct all communication as if he or she
 was working individually (as a "participant"). Every single member of the team should follow all other
 rules.
- Cewas fosters collaboration between individual participants and promotes the forming of new ad-hoc
 or permanent teams. However, the participation fees are calculated based on the actual situation at
 the time of application, regardless any development that may occur in this regard during the cewas
 programme.
- Participants commit to conscientious and personal participation in the programme as well as adherence to the cewas Code of Conduct.
- The application deadline is as specified by cewas.

- Participation fees cover some of the programme costs and include all of cewas services (workshops, events, coaching days, and office space). The amounts do not include VAT.
- Participation fees are due after contract closure. Individual instalments can be agreed based on the financial situation of participants.
- Participation fees are not refundable.

- Participants understand that the service of "coaching" by cewas must be requested actively by the
 participants during the official cewas coaching days. Cewas coaches may also provide individual
 coaching upon request to the participants outside the announced cewas coaching days in Willisau.
 However, this service is upon availability and discretion of the coaches.
- Participants can request that cewas connects them with individuals or organisations, including think
 tank members and other partners from the cewas network. However, cewas reserves the right to
 reject such requests upon its discretion if requests are inappropriate.

Privacy and Intellectual Property:

 Based on Article 13 of the Swiss Federal Constitution and the provisions of federal data protection legislation, everyone has the right to the protection of their privacy, as well as to protection from misuse of their personal details. Cewas complies with these provisions. Personal data is treated as strictly confidential and is neither passed on nor sold to third parties.

 confidentially. Participants agree that their project summaries and profiles can be used in cewas
 project documentation and communication channels. Any further publications require the
 Participants' consent. Further, participants agree on presenting their projects to partner
 organisations and invited guests at events organised by cewas.
- If a participant is worried about confidentiality, cewas suggests that these individuals contact the cewas management in order to evaluate the specific elements. Cewas will not take liability for any information passed on to third parties by other participants or partner organisations.
- By applying to the start-up programme, participants agree that cewas may use the participants' contact information for future activities run by or in correlation with the management of cewas or partners or for any other use that they see fit. The data collected for further use may include (but is not limited to) participants' name, address, email address, and telephone number. The intended purpose of this collection of data is foremostly for administration purposes. It may also be used to notify Participants of any future activities relating to cewas. It may also be used for analytical purposes in order to build statistical and/or analytical tables. At no time will individual participants' information be passed on or sold to third parties without their prior consent. If a participant does not wish to be contacted at any future point, he should notify the management.
- Although cewas endeavours to ensure the security of all correspondence, internet is not a fully secure medium. Cewas is therefore unable to guarantee the security of any data sent electronically by any participant and cannot accept responsibility for any loss or damage experienced through loss of confidential information.

Indemnity Clause

 being held liable. Participants waive any claim and compensation claims. In case of cancellation of
 the programme the participation fees will be fully refunded.

 or punitive damages, regardless of the form of action, whether in an agreement, tort, strict product
 liability or otherwise, even if advised of the possibility of such damages and even if the damages
 were foreseeable.
