This Privacy Policy explains the policies of Kiuas on the collection and use of the information we collect when you access kiuas.com (the “Service”). This Privacy Policy describes your privacy rights and how you are protected under privacy laws.

By using our Service, you are consenting to the collection and use of your information in accordance with this Privacy Policy. Please do not access or use our Service if you do not consent to the collection and use of your information as outlined in this Privacy Policy.

Kiuas is authorized to modify this Privacy Policy at any time. This may occur without prior notice. Kiuas will post the revised Privacy Policy on the kiuas.com website.

Processing of personal data

We process personal data obtained from you directly or via a person who enrolls you to or applies to our events/programs on your behalf. The personal data comprises of the information given when registering to/applying in our event/program. We process your personal data to register you to our events/programs, to organise the events/programs, to provide you with information on our future events/programs, and to develop the events/programs and our other operations. We process your personal data on the basis of the commercial agreement between you and us (GDPR Art. 6.1(b)), our legitimate interests that arise when you register for an event/a program organised by us (GDPR Art. 6.1(f)), and to comply with the legal obligations applicable to us (GDPR art. 6.1(c)), such as accounting and consumer protection. In some cases, we may ask your consent to some other type of processing. In such a case, we will inform you of the respective purposes of processing when requesting the consent and such processing is conducted only subject to the receipt of appropriate consent.

We collect usage data when you interact with our Service. Usage data includes the following:

- Internet Protocol (IP) address of computers accessing the site
- Web page requests
- Referring web pages
- Browser used to access site
- Time and date of access

Retention period

We mainly retain your data for the period required to provide you the services. Your information may be retained for longer periods for reporting, recordkeeping in accordance with applicable laws or other purposes defined above, and anonymised or deleted without further delay once a basis for retention no longer exists. Your contact details may be retained and used for marketing purposes, unless you object to such use. We evaluate the necessity and accuracy of the personal data on a regular basis. Information which does not identify you personally may be stored indefinitely.

Recipients of personal data

We may disclose personal data to our cooperation partners to organise our events/programs and to promote cooperation that enables the events/programs, in which case such disclosures may also be based on the legitimate interest of our cooperation partners. We guarantee that your right to privacy is not endangered by such disclosures. Your data may be disclosed to authorities if required by applicable law.

Your rights as a data subject

You have a right:

- to request access to and rectification or erasure of your personal data;
- to request that the processing of your personal data is restricted or to object to the processing of your personal data; and
- subject to certain preconditions, to receive your personal data in a structured, commonly used and machine-readable format and to transmit that data to another controller.

You may exercise the aforementioned rights by sending a message to the email address mentioned above. Where the processing is based on your consent, you have the right to withdraw your consent at any time. Please notice that this will not affect the lawfulness of processing based on consent before the withdrawal. In case you consider that your rights under the data protection laws are infringed, you may lodge a complaint with a supervisory authority (Finnish Data Protection Ombudsman).

Use of cookies

Our Service uses cookies. Cookies are small text files that are placed on your computer by websites that you visit. Websites use cookies to help users navigate efficiently and perform certain functions. Cookies that are required for the website to operate properly are allowed to be set without your permission. All other cookies need to be approved before they can be set in the browser.

Cookie types:

- Strictly necessary cookies. Strictly necessary cookies allow core website functionality such as user login and account management. The website cannot be used properly without strictly necessary cookies.
- Performance cookies. Performance cookies are used to see how visitors use the website, eg. analytics cookies. Those cookies cannot be used to directly identify a certain visitor.
- Targeting cookies. Targeting cookies are used to identify visitors between different websites, eg. content partners, banner networks. Those cookies may be used by companies to build a profile of visitor interests or show relevant ads on other websites.
- Functionality cookies. Functionality cookies are used to remember visitor information on the website, eg. language, timezone, enhanced content.
