Note: The Form 23 once received by the owner must be lodged into Council within 30 days of the date of the signed Form, or the certificate may be invalid

Type of pool or spa definitions: A relocatable pool or spa is a pool or spa that is contained within a relocatable temporary compliant barrier. If it is located within a permanent barrier then it is a permanent pool or spa.
