17/06/23 - I had the pleasure of attending the Alpine School Community Learning Presentation day at Marlo. I never cease to be impressed by these young leaders and I thank the staff at Snowy Campus for the opportunity to attend.

22/06/23 - I, along with the Mayor and Cr Stow, attended the opening of the new Kmart store in Bairnsdale. Half an hour before opening the car park was full as customers impatiently waited for Mayor Reeves to cut the ribbon!

23/06/23 - I attended the Annual Gippstar Awards in Morwell. Once again, a magnificent celebration of the outstanding athletes from across Gippsland and a wide range of disciplines.

My recent participation in the Australian Local Government Association (ALGA) Conference, held in Canberra from 13-15 June 2023, was a highlight of my past few weeks as a Councillor. It was a great opportunity to represent our Council, gather knowledge, and help contribute to the development of effective strategies for our community's benefit.

During the ALGA Conference, I attended various sessions and panel discussions. The ALGA Conference also served as an excellent platform for exchanging ideas and discussing pertinent issues with local government representatives from across the country. I was particularly interested in the topics of sustainable development, community engagement, infrastructure planning and effective governance.

Sharing insights and experiences from our Council's perspective, I actively contributed to many discussions, creating meaningful dialogue with fellow councillors and industry experts. 07/06/23 - Rejuvenate Workshop at the Hub

I attended with Cr Urie and there were a number of Council Officers present as well as a wide representation of community. It was led by Matt and Maryanne from Australian Centre for Rural Entrepreneurship (ACRE). Very interesting discussion about social entrepreneurs, innovators, using "remnant know-how" in Scottish Highlands more people are employed by social enterprise than traditional enterprise, and the Government plays a real role – Scottish Economic Growth Strategy. This compares with the Victorian Government which has just dismantled its social enterprise team. A social enterprise splits its profits so 50% to a social need and 50% to the investors. Matt recommended that small groups of local community be taken to see examples such as in Corryong and Yackandanda. Social Enterprise Schools now happening in Mallacoota with ACRE and the Wilderness Collective.

10/06/23 - Deep in the Weeds a Winter Festival Event at Sailors Grave in Orbost. An exciting evening with excellent food, alcohol and music.

12-15/06/23 - Australian Local Government Association (ALGA) Conference in Canberra. I attended with Mayor Reeves, Chief Executive Officer, and Cr Crook. We drove there and back in Cr Urie's Electric Vehicle, stopping for a quick top up in Cann River and Cooma. This is a big annual conference with many keynote speakers. A report of key learnings will be provided to Council.

16/06/23 – East Gippsland Art Gallery Launch of Exhibition SouthEast NOW 2023 (Alfie Hudson, Chris Mongta, Patricia Pittman, Alice Ann Pepper, Ray Thomas), and Aunty Rachel Mullett, Jennifer Mullett and Ben Pender. A privilege to see these beautiful works of art collated for this event.

16/06/23 - The Merindas Music Café in Bruthen Mechanics Hall, as part of Winter Festival. This show started with a local youngster playing guitar and singing, and she was excellent, but I cannot recall her name. The Merindas are two well-known singers, who are very professional, great performers, funny and engaging. They had everyone in the audience up and dancing.

21/06/23 - Shearing Shed Lamb Festival at the Stringers Organic Lamb farm, as part of the Winter Festival. It was lovely to spend time on Stringers' farm and stand around fires eating delicious lamb meals.

Facilitated by two (2) leaders from Australian Centre for Rural Entrepreneurship (ACRE) whose purpose is "to drive the renewal of Australia's rural communities so that future generations may thrive". The program works to connect, support, and guide rural people who want to build and sustain community-led initiatives which address a local problem or create an opportunity.

ACRE is a for-purpose social enterprise and I understand Councillors will soon have the chance to learn more through a special workshop. It is very relevant for us to know about and for our communities to utilise.

10/06/23: I enjoyed a truly wonderful evening at Sailor's Grave, Orbost for the fully subscribed, Winter Festival event, "Deep in The Weeds". The event was extremely well organised with fabulous projections by Lee Nickless, great food, interesting diverse crowd with people from many destinations other than East Gippsland and best of all, stunning music. Huge congratulations to Gabby and Chris from Sailor's Grave and the many people who helped pull off such a thoroughly enjoyable event!

10/06/23: Another Winter Festival event had me take my very first bathe at Metung Hot Springs under the stars with Rhonda James guiding us all in a meditation. It was excellent! There are so many fantastic participatory events to enjoy over this month of the festival, 9 June- 9 July 2023 and I have been busy making lanterns with my grandchildren in preparation for the Lakes Lights and Lantern Parade this Friday.

16/06/23: I attended the opening of Southeast Now at the East Gippsland Agriculture Group with the Deputy Mayor and Cr Greacen. It was another social highlight, featuring a number of really talented indigenous artists.

21/06/23: Finally, it was my pleasure to represent Council and officially open the Firewise Garden project at the Nungurner Primary School. Along with the students, teachers, Aboriginal associates, CFA members (with truck), Landcare volunteers, parents, and friends of the school, the happy event was a showcase of the children's learning about these terrific native plants which can be a buffer against bushfires, refusing to ignite despite application of a blowtorch (as demonstrated). We had a smoking ceremony, songs, a BBQ and tour of the new gardens. Information kits were available, and people are asked to spread the word about the plants. These plants could be usefully employed by Council on roadsides and public spaces. Many people contributed to this project which was a wonderful success. (Some pamphlets have been distributed).

Carers Victoria Mingle in Bairnsdale.

Carers Victoria, in its dedication to supporting carers across the nation, has provided us with some insightful statistics and facts:

- There are over 2.65 million carers in Australia, representing nearly 11% of our population;
- Among them, approximately 861,000 are primary carers, providing invaluable informal support to their family members or friends;
- Some 7 out of 10 primary carers are women and I think it is crucial to recognise this.
- the average age of a primary carer is 54;
- 30% of carers provide more than 40 hours unpaid care per week;
- We have 6,040 carers in East Gippsland and Carers Victoria expects these numbers to grow significantly in the next few years; and
- Modelling shows that by the end of 2025, over 1 million Victorians will be unpaid carers that's 1 in every 7 Victorians.

These statistics shed light on the significant impact and challenges faced by carers in our society.

We were proud to be able to partner with Carers Victoria and stand-up an information booth on the day with our helpful Council staff.

07/06/23 - We met with the Upper House MP Tom McIntosh and were able to have a frank and fearless discussion about timber transition among other key topics.

07/06/23 - Youth Ambassadors met.

09/06/23 - One Gippsland Chair-Secretariate meeting took place in anticipation for the 23 June 2023 Board meeting.

09/06/23 - We launched and opened the Winter Festival at Metung Country Club. The Winter festival is a triumph. Well done, Adam, the board and organising committee and all participants!

I also had an opportunity to review the East Gippsland Gallery Southeast NOW exhibition at the Gallery and identified a fabulous piece by local Artist Ray Thomas to add to the shire collection.

22/06/23 - We participated in the official opening of the new Kmart store in Bairnsdale last Thursday. It was a great celebration of a significant retail investment.

27/06/23 - I undertook the monthly "Moment with the Mayor" on the local community radio, REG FM. It's a great opportunity to share the operational work the Shire is undertaking across the region.

13/06 – 16/06/23 - Australian Local Government Association (ALGA) National General Assembly and Australian Council of Local Government Forum (ACLG).

I attended ALGA and the renewed ACLG in Canberra with the Chief Executive Officer and Crs Greacen (OAM) and Crook.

With the local Member, The Hon. Darren Chester, we had opportunities to meet with Federal members regarding the recent Native Timber Harvesting decision in Victoria, as well as attend Question Time, the following was noted:

- Meeting with Mr Peter Dutton and Senator Duniam (Tasmania);
- The Speaker noted and greeted the Mayors present in the Speakers Gallery that day which was an honour;
- Meeting with Minister Murray Watt Federal Minister for Agriculture;
- We noted that the Federal Coalition is strongly advocating for the reversal of the State Government decision; and
- While the Federal Government has a position of supporting a Native Timber Industry, Minister Watt conveyed that the Government would not be intervening in a State Government decision.

I had the opportunity and honour to dine with The Governor General (GG) and Mrs Hurley at Yarralumla.

24 Mayors from areas with disaster declarations that the GG had visited in the past 3 years were invited. It was a considerable honour to be able to represent our community in this company and at this location. We have written to the GG thanking them for the support and recognition.

ALGA was busy. 537 Councils and Mayors were represented with 1100 delegates. The first day was the Rural Council Forum and we were able to represent our shire well. I make and take an opportunity to speak and ask questions in these forums and think it is important to do so. There were some 145 motions debated at ALGA, including five (5) of ours all of which were carried. There were excellent and insightful speakers and the professional interactions and associations that were forged or remade are important.

Ministers McBain and King were in attendance most of the time and made addresses to the forum. Panel discussions were on topics including the Future of Local Government, Workforce, development and delivery of policy in Local Government, The VOICE, Cyclones-Fires-Floods, Affordable Housing and Building More resilient infrastructure.

The ACLG dinner enabled Mayors to dine and talk with front bench Minister, including the Hon. Michelle Rowland MP Minister for Communications the Hon. Chris Bowen MP Minister for Climate Change and Energy and a quick moment with the Prime Minister.

At the forum, ACLG we were able to question the Education Minister about post code and regional education disadvantage, and the Hon. Catherine King about the review of Infrastructure grants that is affecting our projects at Orbost, Mallacoota, Sarsfield and Lakes Entrance. While we are writing to the Minister, being able to speak in a forum face to face was most effective.

23/06/23 - One Gippsland June Board Meeting

This reporting period also included the One Gippsland (OG) Board Meeting.

OG is important and an emerging entity and we are still growing and finding our way. The agenda was rich and varied and included not just regular reports from our partners such as Food and Fibre, TAFE, Federation University and Gunaikurnai Land and Waters Aboriginal Corporation (GLaWAC). We also discussed and interrogated our recent positions on the State and Federal Budgets, and this gave rise to conversations about our Charter and Terms of Reference.

The Latrobe Valley and Gippsland Transition Plan was discussed, and the following outcomes resolved:

- One Gippsland Secretariat to organise a meeting with Mr Chris Buckingham CEO, Latrobe Valley Authority and Ms Beth Jones – Deputy Secretary Rural and Regional Victoria, Department of Jobs, Skills, Industry and Regions to discuss the finalisation of the Latrobe Valley and Gippsland Transition Plan and the development of the Action Plan:
- One Gippsland Members to provide individual feedback on the draft Latrobe Valley;
- Gippsland Transition Plan to the Secretariat; and
- One Gippsland Secretariat to combine One Gippsland member feedback on the draft Latrobe Valley and Gippsland Transition Plan into a consolidated One Gippsland feedback document.

Also discussed were:

- Offshore renewable energy position and policy;
- One Gippsland Flood and Inundation Policy Paper;
- One Gippsland Early Learning Education Policy Paper; and
- OG Workwell Fund Grant Application (see below).

OG Collective and Gippsland Centre Against Sexual Assault (GCASA) will work with Local Government across Gippsland to strengthen and support existing organisational structures and create new initiatives to reduce workplace gendered violence including sexual harassment. We know more work needs to be done to stop gendered violence and sexual harassment in the workplace and for people to feel safe to report behaviours of concern and behaviours that impact people's mental health.

This project aims to integrate with and expand on existing resources, training and support mechanisms to ensure organisational structures and systems support leaders in their responsibilities and what they can do to keep their staff safe at work and in their community. We will collaborate with our partners to identify risks and barriers to reporting and develop capacity building mechanisms such as training to reduce workplace gendered violence and sexual harassment.

Our overall aim is to increase both individual and organisational capacity and confidence in eliminating gendered violence and sexual harassment. We have an upcoming stakeholders register that includes our next meeting scheduled to be in Melbourne and the delegation to Canberra for our Advocacy. OG agreed to review and renew the Advocacy paper in light of budgets, changing and emerging priorities across the region.

- (b) The general rate be declared for the period commencing 1 July 2023 and concluding on 30 June 2024:
 - i) It be further declared that subject to paragraph (iii) of this Part, the general rates be raised through the application of differential rates.
 - ii) The following rates in the dollar apply to property classifications:

- iii) Differential rates apply to rateable properties with the following characteristics:
 - (a) General

General land is any land that is:

- Used primarily for residential purposes; or
- Unoccupied but zoned Residential, Township or Rural Living under the East Gippsland Shire Council Planning Scheme; or
- Any land that is not defined as Farm Land or Commercial/Industrial Land.
- (b) Commercial and Industrial Commercial and Industrial Land is any land used primarily for:
 - the manufacture, or production of, or trade in, goods or services; or
 - Obviously adapted for the primary use of commercial or industrial purposes; or
 - Occupied primarily for the purpose of service delivery for tourism leisure and/or accommodation; or
 - Unoccupied but zoned Business, Industrial, Mixed Use, Special Use or Comprehensive Development Zone under the East Gippsland Shire Council Planning Scheme; or
 - Conforming to East Gippsland Shire Council guidelines for the classification of property as Commercial/Industrial Land.

(c) Farm Land

Farm land is defined as any land which:

- Is used primarily for a farming or agricultural business; and,
- Conforms to the definition of "farm land" as specified within the Valuation of Land Act 1960; and,
- Conforms to East Gippsland Shire Council guidelines for the classification of property as "farm land" as stipulated within East Gippsland Shire Council's "Application for Farm Rate"; and
- The ratepayer has Primary Producer status with the Australian Taxation Office and be located in a Farm Zone in accordance with Council's planning scheme, or have a permit from Council to operate a farming business.
- iv) Council has determined that the application of a differential rate for Farm and Commercial/Industrial Land will contribute to the equitable and efficient carrying out of its functions.
- v) Council has determined that the differential percentage applied to Commercial/Industrial properties for the Economic Development Discretionary fund be 5 percent.
- vi) Council has determined it will provide a rate rebate equivalent to \$62.47 to eligible properties in the ownership of pensioners who qualify for a Victorian Government approved pension rebate. This rebate is provided in accordance with section 169(1)(a) of the Local Government Act 1989 and supports the development of the municipality in that it helps support pensioners to keep and stay in their own homes.
