Luther School Board Passes Improvements to Wellness Policy

The Board adopted additions to their wellness policy to improve the health of students and staff per the recommendations of Elevate Student Health.

LUTHER, OKLAHOMA (June 26, 2023) – On Monday, the Luther School Board passed improvements to their district wellness policy, a move that will impact the health of over 800 students in the school district located in Oklahoma County.

The policy updates include improving the nutritional requirements for food provided on campus, increasing physical activity for students in the district, and encouraging community participation in the development of future wellness policies.

Luther High School students participating in <u>Elevate Student Health</u> recommended updates to the district's wellness policy based on evidence for what would have the greatest impact on youth and staff health.

Elevate Student Health is funded by the <u>Tobacco Settlement Endowment Trust</u> (TSET) through the <u>Youth Action for Health Leadership</u> (YAHL) program.

Boomer Pridemore, an incoming Sophomore at Luther High School, spoke about why improving wellness policies is important to him.

"We worked on the wellness policy to make sure that everyone in our district has healthy options," Pridemore said.

Most children consume as much as half of their daily calories at school, so schools have a tremendous opportunity to improve the health of their students. This is why Elevate Student Health partners with districts across the state to improve their wellness policies through greater access to nutritious foods, increased physical activity and more opportunities to drink water throughout the day.

Data from 2020 showed Oklahomans 10-17 years old experience obesity at 18.7%, one of the highest rates of childhood obesity in the nation. While weight does not equal health, children with obesity are more likely to develop chronic health conditions such as cardiovascular disease, Type 2 diabetes and mental health conditions.

Physical inactivity and poor nutrition are two of the greatest behavioral risk factors for obesity. Only 26.1% of Oklahoma high school students are physically active for 60 minutes per day, while 22.3% of students drink one or more sodas each day.

Luther Superintendent Barry Gunn said: "I'd like to thank these youth for all of their hard work on revising our policy and taking time to take on extra work to improve the health of everyone in our district."
