### The Case



**April 1, 2009**

Young Bhavesh More was one of my more challenging cases. His folks had written him off as a "gonner" and his mother believed he didn't have long to live. The child barely spoke; he was swollen all over; he had not eaten for days; and he had stopped urinating, leading to toxic build-up. The child was also suffering from hypertension.

Bhavesh Sudhir was suffering from renal artery stenosis (RAS), a condition where the main artery supplying blood to the kidneys narrows considerably. RAS causes the kidneys to produce increased amounts of the hormone rennin, which raises blood pressure. Bhavesh's was a severe case of RAS and his blood pressure was dangerously high.

The boy's health was deteriorating rapidly and he was admitted to hospital for around a month, where he was pumped with allopathic

drugs. But nothing seemed to help and a day after he was discharged from hospital, his mother brought him to **MindHeal Homeopathy**.

### Assessment

Bhavesh took ill soon after his uncle died. His own father had died when he was an infant and his uncle was a like father to him. Even more traumatic was the fact that they boy saw his uncle collapse and die before his very eyes.
