will be paid in equal installments through FACTS drafts

Re-registration will take place February 1, 2022, through February 22, 2022
Returning students re-registered after the deadline will incur a \$125.00 late fee

Additional Students registering from the same family are eligible for a \$500.00 discount per registered child per tuition paid per year.

Exceptional Needs Fee \$1,750.00 per recipient

Exceptional Needs fee will be adjusted should the fee exceed the award

Tuition Assistance Applications are available online at <https://factsmgt.com> Families applying for Tuition Assistance must be in good financial standing with the school for consideration. Tuition Assistance application fee is \$35.00.

Tuition Options:

- **Monthly Drafts through the FACTS Tuition Management Program.** Payments are budgeted over 12 months, July, 2022 through June, 2023. Payments are automatically drafted from an account or credit card designated by you on the 5th or 20th of each month. Payments on a credit card will be charged an additional processing fee by FACTS.
- **Paid in Full.** Tuition Paid in Full by Tuesday, July 12, 2022 by 3:30pm is eligible for a 3% discount. The 3% discount may not apply if other financial assistance or scholarships have been awarded. Families electing to pay in full should select a payment day of the 20th.
- **Incidental charges** such as field trips, lost books, etc. will also be billed through FACTS.

FACTS charge is \$47.00

After School Program:

Full Time per child \$200.00 per month*

Part Time per child \$ 20.00 Daily

Early Dismissal Mondays per child \$ 30.00 Per Early Dismissal Monday

Late pickup Fee \$10 for the first 15 minutes; \$1 per minute additional after the first 15 minutes.

*Payable 9 months September 2022 through May 2023 (August included in December payment)

After School Program Payment Options:

- Payment for the After School Program may be made directly to the School Office via cash or a check made payable to St. Peter's Catholic School.
- Or through a FACTS draft. The After School Program charges will be drafted monthly along with your tuition/fee draft.

REQUIRED DOCUMENTATION ALL STUDENTS

The following documentation must be on file in the School Office prior to the start of the school year.
Non-refundable Student Registration Fee must be paid upon re-enrollment.

Failure to submit updated documentation, payment of fees and/or tuition payments upon request may result in suspension until the missing documentation, fees and/or tuition is received and accepted.

- Non-refundable Student Registration Fee of \$275.00
 - Baptismal Certificate Copy required for Catholic students
 - Copy of Birth Certificate
 - Original Immunization Record (SC DHEC 2740)
 - St. Peter's School will contact student's home parish to verify registration, attendance and support of identified home parish. Family must be in good standing with home parish to receive parishioner rate.
 - St. Peter's School will contact transferring student's previous school for records.

Students withdrawing from St. Peter's Catholic School at any time during the First Semester of the school year are required to pay the remaining balance of half of the annual tuition rate. Students withdrawing at any time during the Second Semester of the school year are required to pay the full tuition price. Tuition is not pro-rated based on days attended. Transcripts and records will not be released until the balance is paid in full.
