**Resolution # 40** Type 11 Action (2020 CDBG) Where the Town will apply for funds and anticipates funds to be awarded through the Community Development Black Grant from the U. S. Department of Housing and Urban Development, as administered by the State of NY and Public infrastructure Project (DFA #104745) to replace obsolete and inaccurate water with radio read meters and related software throughout Black Brook Water Dist. 1, and install pressure reducing valves to customers where appropriate.

Supervisor Jon Douglass sent a request to wave the Income survey requirements for the Towns proposed application for the 2020 NYS CDBG block grant and they accepted out request.

First Quarter Water Sewer billing was presented. Ronnie Wilkens made the motion to accept as presented and James Seguin 2<sup>nd</sup>.

The new Billing system for the Water and Sewer billing will take anywhere from 3 to 6 months.
