## **Hometown Heroes Townships of Jay/Black Brook Banner Terms & Agreement**

This document serves as testimony that applicants wishing to secure a Hometown Heroes Banner in the Townships of Jay/Black Brook must agree to the terms set forth to obtain said banner by Hometown Heroes Townships of Jay/Black Brook Banner Committee, (known as Committee in this document)

The applicant must fill out the application form supplied by the Committee in full and must be signed/dated in ALL areas directed as "APPLICANT." If application is not filled out completely it will be denied and returned. The applicant has 5 days to return the application to the Committee, if the form is once again in errors it will be denied and discarded for that calendar year. The Committee must adhere to a strict dateline to ensure all applications are submitted to the manufacturer so the banners can be produced, a demo production copy be sent and approved by Committee, then the applicant can view the demo production copy and approve, then approval to be produced, shipped and installed before Memorial Day and removed after Labor Day.

The Committee is NOT responsible for the following; Changes on the banner after the demo production banner has been viewed and been approved by applicant, the Committee will NOT REFUND the cost of the banner after it has been sent to the manufacturer for creation, the Committee will NOT replace, refund, repair any damage to the banner for any reason. The Committee will take reasonable care of said banner when it is in their possession during the seasons that the banners are not installed on the poles. Furthermore, the applicant is given the privilege of taking possession of their banner to take home. This MUST be done the day the Committee is uninstalling the banner/s to put them in storage for the Fall/Winter months. The committee will announce when the banners are being removed from the poles in an ample time frame to ensure the applicant can obtain their banner.

The documentation required to considered and obtain a banner must also be submitted with the application. The requirements are as follows; Served or serving in one of the following branches of the United States Military; Army, Navy, Marines, Air Force Army National Guard and Coast Guard. Honoree must be discharged from Military Service under Honorable conditions. Submit a DD-214 or certificate of separation as proof of Military Service AND, be a current resident of either townships of Jay/Black Brook, attended either Au Sable Forks Central School or Au Sable Valley Central School. AND/OR be a family member of a long-term resident of 20 years or more.

A "HIGH RESOLUTION" photograph is required and once provided will be converted to B&W. Banners are 3'x5' in size and because of the size it is IMPERATIVE to obtain the High Resolution photo. The Committee strives to create the very best Hometown Hero Banner possible so the public can view each and every banner from their automobiles or on foot.

Once this application is signed and dated it serves to all that the terms are acceptable and FULLY understood by the applicant. There will be ABSOLTELY NO special circumstances to null and/or void this agreement.
