SWEEPSTAKES OFFICIAL RULES AND REGULATIONS

Overview: No purchase necessary. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited or restricted by law. Open to residents of Arizona, Colorado and Texas. Must be 18 years of age or older. All federal, state, and local regulations apply.

- 1. **Sweepstakes Period.** The #YourCallBirdcall sweepstakes promotion (the "Sweepstakes") begins at 9:00:00 am Central Time on January 20, 2024, and ends at 9:00:00 pm Central Time on January 27, 2024 (the "Entry Period"). Winners will be determined by Birdcall Holdings, LLC ("Sponsor") following the end of the Sweepstakes Period. Sponsor's computer is the official timekeeping device for the Sweepstakes.
- 2. Eligibility. The Sweepstakes is open to individuals who are (i) legal residents of Arizona, Colorado, or Texas and (ii) 18 years of age or older. An eligible individual who follows the guidelines set forth in these Official Rules and attempts to enter the Sweepstakes during the Entry Period is hereafter referred to as a participant ("Participant"). - 5. Random Drawing; Odds of Winning. Winners will be selected randomly on each day of the Sweepstakes Period. Odds of winning depend on the total number of eligible Entries received.
