SUPERCHARGED LEVEL III

This exclusionary coverage is our most comprehensive protection. Available for all EVs 2 years old or newer, up to \$150,000 MSRP, and with up to 24,000 miles on the odometer at the time of purchase of the vehicle service agreement.

SUPERCHARGED LEVEL II

Provides our highest level of "stated component" coverage. Available for all EVs 2 years old or newer, up to \$150,000 MSRP, and with up to 24,000 miles on the odometer at time of purchase of vehicle service agreement.

Deductible:

SUPERCHARGED:

Available \$0, \$50, \$100, and \$200.

\$100 Disappearing (at selling dealership).

RECHARGED:

Available \$100 and \$200.

\$100 Disappearing (at selling dealership).

Standard deductible of \$100 for both Agreements. \$0 and \$50 deductibles are only available on Supercharged options.

Additional Benefits:

- Reimbursement of manufacturer's deductible for parts under manufacturer's warranty and covered by the service agreement up to \$100 per occurrence⁽¹⁾
- Reimbursement for car rental while vehicle is repaired due to a covered mechanical breakdown up to \$50/day for 7 days; reimbursement for rideshare while vehicle is repaired due to covered mechanical breakdown up to \$50/day for 2 days⁽¹⁾
- Reimbursement for meals and lodging while vehicle is repaired, when 100+ miles from home⁽¹⁾

RECHARGED LEVEL II

Provides our mid-level of "stated component" coverage. Available for any pre-owned EV 8 years or newer, up to \$120,000 Vehicle Purchased Price, with up to 24,001 to 100,000 miles at the time of purchase of the vehicle service agreement. Optional Electric Propulsion Battery and Battery Cooling System Coverages available.

RECHARGED LEVEL I

Powertrain Component coverage offering protection for electric/traction motor, high voltage cables, battery management system, transmission and more. Available for any pre-owned EV 8 years old or newer, up to \$120,000 Vehicle Purchased Price, with up to 24,001 to 100,000 miles at time of purchase of the vehicle service agreement.

Options:

Battery Coverage: Available for an additional fee on Recharged coverage levels. Included on Supercharged coverage.

Lift Kit: Available with a surcharge on all standard vehicle plans.

Oversized/Undersized Tires: Available for an additional fee on all standard vehicle plans.

Personal Use Snowplow: Available with a surcharge on all standard vehicle plans.

Commercial Use: Available with a surcharge on all standard vehicle plans. High-Tech: Available for an additional fee on Level I and II coverages only.

Included on Level III coverages.

Compromised Vehicle Protection:

In the event that the customer's vehicle is determined to be hacked, National Auto Care will reimburse up to \$1,000 to reset the vehicle to the manufacturer's preset settings.
