

Privacy policy –

Because QBT website owner (hereinafter "the website") respects the privacy of the users of the website he manages and operates. The website owner has decided to publish his policy regarding the protection of privacy on the website, and he undertakes to the user to comply with this policy.

The purpose of the policy is to explain what the website owner's practices are in relation to the privacy of the users of the websites, and how the website owner uses the information provided to him by the users of the website, or collected while using the website.

The privacy policy is in accordance with section 11 of the Israeli Privacy Protection Law 1981.

General

When using the website's services, information about you is collected. Some of the information identifies you personally, i.e in your name and address, services you purchased, the means of payment used by you, etc. This is the information you knowingly provide, for example when registering for services on the website. Some information does not personally identify and is not stored, this is statistical and cumulative information, for example, advertisements you read on the website, the pages you viewed, the offers and services that interested you, the Internet address (IP) from which you applied and more.

Registration for services

To the extent that personal information is required when registering for services on the website, the website owner will only ask you for the information directly necessary for the provision of the services.

Databases

The data collected as well as content that the user uploads and / or shares and / or creates on the website, will be stored in the site's database.

The database is stored on storage servers that may be located in the State of Israel or outside of it. The user of the website declares that he agrees to the storage of the information even outside the borders of the State of Israel.

Use of the information

The use of the information collected will only be made in accordance with this privacy policy or in accordance with the provisions of any applicable law, in order to –

- Allow the use of various services on the website
- Improve the services and content offered on the website
- Modify or cancel existing services and content
- For the purpose of purchasing services on the website - including publishing information and content
- In order to fit/match the ads that will be displayed when you visit the website to your areas of interest
- For control purposes
- For the purposes of establishing a commercial and / or marketing relationship

The information that will be used by the business will mainly be statistical information, which is not personally identifiable.

Newsletters

The owner of the website is interested in sending you from time to time by e-mail, Information about his services as well as marketing and advertising information.

Such information will only be sent to you, if you have given your express consent, and at any time you can revoke your consent and cease receiving it.

The website owner will not give out your personal information to advertisers. However, he may pass on statistical information about the activity of users of the site to third parties.

Transmitted statistical information will not personally identify you.

Providing information to a third party

The website owner will not pass on to third parties your personal details and information collected about your activity on the website except in the cases listed below:

- In the event of a legal dispute between you and the website that will require the disclosure of your details;
- If you perform on the website actions that are against the law;
- If a court order is obtained which instructs to provide your details or information about you to a third party;
- If QBT sells or transfers in any way the activity of the site to any corporation - and in the event that it merges with another legal entity or merges the activity of the site with the activity of a third party, provided that this corporation accepts the provisions of this privacy policy towards you;

Cookies

The website uses "cookies" for the purpose of its regular and proper operation, including to collect statistics about the user's use of the website, to verify details, to adjust the website to your personal preferences and for information security purposes.

Modern browsers include the option to avoid accepting cookies. If you do not know how to do this, check the help file of the browser you are using.

Third parties Ads

This document is protected by copyright law and may not be used without the permission of the copyright holder

The website allows other companies to manage the set of advertisements on the website. The ads you see when you visit the website come from the computers of those companies. To manage their advertisements, these companies place cookies on your computer. The cookies allow them to collect information about the websites where you viewed the advertisements they placed. These companies use of cookies is subject to their own privacy policies, and not the website privacy policy.

Data Security

The website implements up-to-date information security systems and procedures in order to keep data security. While these systems and procedures reduce the risks of unauthorized intrusion, they do not provide complete security. Therefore, the website does not guarantee that its services will be completely immune from unauthorized access to the information stored in them and the user declares that he is aware and agrees to this.

Changes to Privacy Policy

In any case where substantial changes are made to this privacy policy, a notice will be published on the home page of the sites about 14 days before the date of the changes.

Report an invasion of privacy

Right of access to information

By law any person may review the information kept about him.
