# **CCRCD BOARD MEETING MINUTES**

June 21, 2022

**PRESENTATION**: Victoria Woolfolk, Watershed Conservation Coordinator, CCRCD. Victoria Woolfolk introduced herself and described her education and previous work experience. Victoria Woolfolk ended by mentioning that she will be in charge of the Alhambra Watershed for the District.

Walter Pease made a motion to approve the Items # 1 & 2 of the consent calendar as presented. Bethallyn Black seconded the motion. Motion passes 4:0.

# **DETERMINATION ITEMS:**

- **8.1** Consider Approving contract with the Carbon Cycle Institute. Ben Weise discussed the partnerships involved with this "Healthy Lands, Healthy People" project, describing the purpose to develop a Carbon Farm Plan to sequester carbon. Following the discussion, Walter Pease made a motion to approve the contract with Carbon Cycle Institute. Bethallyn Black seconded the motion. Motion passes 4:0
- **8.2** Consider Approving contract with the Contra Costa Farm Bureau for work related to the "Healthy Lands, Healthy People" project. Ben Weise described the benefits of building cooperation with local farmer and developing an outreach plan for collaboration with the local Farm Bureau. Following this discussion, Bethallyn Black made a motion to approve the contract with Contra Costa Farm Bureau. Walter Pease seconded the motion. Motion passes 4:0

- **8.3** Consider approving contract with Restoration Design Group for work related to the Marsh Creek Restoration Planning Grant. Ben Weise presented the plan to the Board mentioning that it is the contract for work already presented. Following a few questions and answers, Walter Pease made a motion to approve the contract with Restoration Design Group for work on the Marsh Creek Restoration Planning Grant. Bethallyn Black seconded the motion. Motion passes 4:0
- **8.4** Consider approval of FY 2022-2023 Budget. Chris Lim presented the proposed budget by listing the grants included in the budget and explaining the projected staff increases. After noting that the Finance committee met and recommends the budget, Walter Pease made a motion to accept the proposed FY 2022-2023 budget as presented. Bethallyn Black seconded the motion. Motion passes 4:0

#### **DISCUSSION ITEM:**

- **9.1** Chris Lim updated the Board on CARCD's JEDI policy, noting that the meetings are continuing. The Board finished by inquiring whether there was anything the District could do to assist CARCD in this process.
- **9.2** Chris Lim led a discussion on the current COVID status as well as local counties' reaction and new policies being implemented. A discussion followed with a recommendation to review the District's COVID policy. In the end, the Board agreed that returning to in-person meetings should be done with caution.

## **REPORTS:**

- **10.1** President Reports— Igor Skaredoff graciously noted that this was his last meeting as the President of the District and offered his congratulations and confidence in his successor, Walter Pease. Igor Skaredoff ended his report with an update of his participation in many other agencies.
- **10.2** Directors' Reports Renee Fernandez-Lipp offered her gratitude to Igor Skaredoff for all the work he has done for the Board as well as the respectful environment he created.
- 10.3 Staff Reports— There were no questions on the reports.
- **10.4** Executive Director Reports Chris Lim reported on the current status of several outstanding grants and finished by giving an update on a couple of current contracts and projects.
