Austrian Cultural Forum and feld72 attach utmost priority to responsible handling of data.

It is important to us that you know when we collect which data and how we process this data.

#### PURPOSE OF PROCESSING:

Personal data that you disclose via the online form for submission of ideas for the <u>Catalogue of Possibilities</u> or by e-mail are handled responsibly the *Austrian Cultural Forum Tel Aviv* and *feld72* and are used exclusively in the context of the <u>Catalogue of Possibilities</u>. The purpose of processing of personal data (e.g. name and e-mail address) in the context of the <u>Catalogue of Possibilities</u> is to ensure that persons credited as authors of the individual submissions can be identified and that their identities can be assigned to their respective submission.

#### PERIOD OF DATA STORAGE AND ONLINE PUBLICATION:

The personal data provided via submissions of ideas to the <u>Catalogue of Possibilities</u> are to be stored until the decision of the jury on the awarded projects has been communicated (jury decision expected to take place in May 2021).

For the purpose of identifying the individual ideas submitted for publication in the *Catalogue of Possibilities* online, the names of the persons credited as authors of the individual submissions will remain online indefinitely, unless notified otherwise by the data subject or his or her legal representative.

### LEGAL BASIS FOR THE PROCESSING:

The Austrian Embassy (Austrian Cultural Forum) as part of the Federal Ministry for European and International Affairs processes data in accordance with the General Data Protection Regulation (GDPR, Regulation (EU) of the European Parliament and the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC) and the Austrian Data Protection Act (Bundesgesetz über den Schutz personenbezogener Daten, Federal Act concerning the Protection of Personal Data, Federal Law Gazette I No. 165/1999 as amended).

#### **RECIPIENTS OF THE DATA:**

Data processed by the Austrian Embassy (Austrian Cultural Forum) and *feld72* will only be transferred to other third parties if required by law or court order.

### **RIGHTS:**

You have the general right to information, rectification, deletion, restriction, data transferability, revocation and objection.

You have the right to information regarding the processing of your personal data by feld72 architects, Liebling Haus and the Austrian Cultural Forum.

Please inform us if your data processed by us is not correct. We will correct this data without delay and inform you that it has been corrected.

If data is processed based on your consent, you can revoke your consent at any time. This does, however, not affect the legality of data processing performed on the basis of your consent until the latter has been revoked.
