Scope of the Contract

- Utilise the Pre-Construction Information and existing H&S File to ensure correct risk management arrangements are in place.
- Produce a supplementary Construction Phase Plan for notifiable schemes and distributing to allow works to commence

Contract Management

The contract for South Wales Police was managed and monitored by Peter and Charles Caddy, ensuring each work package was appropriately programmed and delivered on time, whilst mitigating any risks and concerns.

Peter and Charles maintained a collaborative approach with South Wales Police, other contractors involved in service delivery, and subcontractors employed by us for specialist elements.
