COVID-19 → HUMAN RIGHTS VIOLATIONS

Early responses characterized by:



Travel bans



Lockdown/quarantine policies





Measures to ensure compliance (e.g., consequences for failing to adhere to lockdown measures)

Which violated:

- Right to freedom of movement
- Right to liberty and security of person
- Right to be free from cruel or degrading treatment
- Right to nondiscrimination
- Among others

SEARCHING AND SCREENING

Data source: NexisUni

Il search strings clustering key terms re:

- COVID-19
- Public health actions
- Human rights

Process:

- Searches run in 7-day increments
- First 1,000 results exported and screened
- Timeline: January 4th, 2020 → Present day (goal)

Inclusion Criteria

Discusses policies (inaction) by a national or subnational government in response to COVID-19

AND

Describes active human rights-related implications of that action, which may or may not be explicitly labeled as such.

CODING

Geographic information






