Public Works:

No meeting last week.

- Councillor Paul asked about Town vehicles using Jacob's Lane to get into the Town yard. It was indicated that it is easier for some of the larger vehicles to turn onto Jacob's Lane instead of Centennial Road as they do not have to turn so sharply or worry about vehicles parked on either side of the road. This matter will be discussed further at the next Public Works meeting.
- Councillor Oram brought forward a resident's concern about the No Turning sign on Marine Drive. Currently, the sign can only be seen after vehicles have turned. It was suggested to move this sign so it is visible to oncoming traffic. The Town Clerk recommended getting direction in writing from the resident indicating that they are okay with the Town moving the sign to a spot near their driveway.
- Councillor Stockley addressed the Rules of Procedure and suggested that matters such as those mentioned above by Councillors Oram and Paul be brought in before meetings so the Town Clerk and Administrative Clerk have time to compile the information.

Human Resources:

 The Vehicle Usage Policy was discussed. The current Policy states that Town vehicles must be returned to the yard at the end of every workday. Public Works is wondering if, in the event of a forecast of heavy snow, on-call employees would be allowed to take the vehicles home in the interest of expediting snow clearing. Councillor P. Lush indicated he prefers to have this stipulation added to the policy. This matter will be further discussed at the next Regulations meeting.

 There were thirteen applicants for the Utility Worker position. Four have been shortlisted for interviews which will be conducted next week.

Strategic Planning:

Three grants were discussed. The first grant will provide funds to upgrade Joey's Lookout with fresh sod, shrubbery, bear-proof recycling bins and solar lighting. The second grant is from NL Power for updates to the lighting in the Town Garage. The third grant is from the Senior Social Inclusion Fund which offers funding in the amount of \$3,000.00. This grant will be used for cold plates, board games, crafting materials, quilting supplies, coffee, tea, snacks and line dancing. The application for this grant is ongoing.

Age Friendly:

- The discussion focused on what grants are best to apply on.
- Craft Afternoon was cancelled as it was scheduled at the same time as the Salvation Army's teatime.
- The door trim has been fixed at the GCYC and an electrician has been engaged to look at the motion sensor light. The problem with the toilet has also been fixed.
- The committee is looking to get AED training. The Fire Dept. may be able to provide the training.
- There was a discussion on the possibility of a crosswalk by the GCYC. It was discussed
 to send correspondence to Minister Loveless, Minister of Transportation and
 Infrastructure regarding this matter.

Communications:

- Councillor Stockley discussed Voyent Alert's ability to narrow communications down to individual neighborhoods and street, suggesting that in a town of Gambo's size this feature is most likely unnecessary.
- Councillor Stockley also sent an email to fellow Councillors on how to set up and use shared folders in Google Docs. He also mentioned that while Drop Box is a useful tool for sharing information, it does not allow real-time collaboration that Google Docs features.
- The April newsletter is complete and features information about the tax collection and emergency preparedness, including the new Voyent Alert system.

Recreation:

- Chase the Ace will begin at the Lions Club on May 11th.
- Afterschool Sports will end after the May long weekend.
- Only two Canada Summer Jobs positions have been approved for this year.
- Active NL granted \$1,500 this year which marks a significant cut from last year.

 is the poor state of the bridges on the trail and how this poses safety concerns. Council's

priorities will remain the same for the trails but will commit to ensuring that the Middle Brook trail is safe for residents.

Gambo Public Library:

- The library is seeking approval to place a mini-library box near the David Smallwood Park office. If this box goes well, they would like to add another by the Fun-N-Sun.
- The Library Committee is currently seeking new members.
- An indigenous section will be added to the library.
- A Craft Afternoon will be hosted on April 27th. The focus will be on creating handmade wool squares which will be used as part of the Come from Away set design.
- The Summer Reading Program is seeking youth volunteers.
- Over the past year the library has hosted 141 programs with 450 adult and 1,095 children visitors and 6,330 books circulated.

Town Clerk's Report:

- I have Doug Evelley, Town Foreman and Kevin Paul, registered for the Water Distributions Basics Training Course for May 2nd – May 5th in Grand Falls-Windsor.
- The property owner of 10 Cabot Road has been approved for her home-based hair salon business. She is requesting a letter from Council stating that we support another business of this type in town.
- I had a conversation with Dave Dillon, Department of Tourism, regarding the upcoming Come from Away Events. He wanted to know if we wanted flags/banners for the town. He advised me that they are expecting a shortage of Screech and suggested that we purchase now. We further discussed the "Warm Embrace" and that they wanted to come to town this week.
- I have received the report on the Investigation of Indoor Air Quality and Mould Growth at the Gambo Community Youth Centre.
- I am in discussions with the RCMP on the vandalism at the Fun-N-Sun Washrooms to determine the options available to us to rectify this matter.
- The Freightliner has been repaired and arrangements are being made to have it shipped back.
- Peter and I had a meeting with Woodrow Mullett and Arnold Beck regarding the Age-Friendly Grant. They want to apply on a project in conjunction with the Age-Friendly Committee. They asked if we would forego the repairs to the Dominion Point Trail and do the required work on the Middle Brook Trail.
- The Water Intake Extension Project has been sent to tender on Friday, April 21st to be advertised for ten business days.
- The Consultant Procurement Limited Call Bid for Pine Tree Road Upgrades has been closed and Allnorth Consultants were the lowest bidder in the amount of \$74,291.52.
