Business Arising from the Minutes:

- Councillor Stockley asked for an update on funding for a Virtual Museum. The Town Clerk noted that there is information in the Action Required Correspondence regarding this matter.
- Councillor Stockley requested an update on the Track and Field lighting. It was noted that the land is currently still awaiting assessment by MAA. This assessment is expected to be received in December.

- Councillor P. Lush apologized for his misunderstanding regarding the Sensory Inclusion Trail Committee. He did not realize that it was a sub-committee of the trails committee of SEDCOR. Councillor Lush also clarified that the motion regarding SEDCOR made at the last Regular Meeting of Council did not dissolve SEDCOR; instead, the motion disbanded the current Board of Directors as they were not meeting the needs of Council and Council was overwhelmed. Councillor P. Lush further elucidated that this motion was not meant as an insult to the SEDCOR Board of Directors. As well, he indicated that communication was an issue and the Board was dysfunctional. He concluded by stating that he stood by the motion and didn't intend to change it.

Item: Municipal Assessment Agency Training Course

The Municipal Assessment Agency is offering a free training course on the Fundamentals of Property Assessment. This course is available online to anyone interested.

Item: TRACT Consulting Ltd. - Unencumbered Lands

Tract Consulting Ltd. is offering a service to identify all unencumbered land within the town in an effort to support economic development and to create a database to effectively manage land. The cost associated with this service is approximately \$15,000.00 - \$20,000.00 plus HST and expenses. Gas Tax monies can be utilized towards the cost of this service.

Item: Central Newfoundland Waste Management 2024 Operational Budget and Tipping Fee Schedule

Due to the increasing costs of parts and services, fuel and salaries, in 2024, the residential curbside collection fee will increase from \$90.00 per household to \$95.00. Further, due to the same cost increases in collection, the disposal fee will increase from \$140.00/tonne to \$145.00/tonne.

Item: SEDCOR – Come from Away Exhibit Items

SEDCOR Tourism is suggesting moving the Visitor Information Centre and the Come from Away 9/11 Exhibit to the Walsh House. It was noted that there are several storyboards planned as part of the exhibit and it was not completed during the summer of 2023. It was recommended that SEDCOR Tourism hold off producing the storyboards as there might not be enough space to display them in the Walsh House. Lorne, Town Clerk was advised to contact Sherry Parsons.

Item: Mental Health Counseling Services

Mental Health Therapist, Andrea Foote is offering an online counselling service across Canada through her St. John's based practice - Accessible Advice. She is requesting that we share her information with the town. It was suggested to place her business card on the Town's Facebook page.

Item: Community Enhancement Employment Program

A Community Enhancement Employment Grant in the amount of \$8,047.00 has been received. This project will complete washroom upgrades at the Walsh House.

Item: Lift Station Retrofit

A Notification of Project Approval has been received regarding the retrofit of Lift Station 7. The total cost of this project is \$191,660.00 with a contribution of \$17,380.00 by the town.

Item: Sensory Trail Committee

The Sensory Trail Committee has presented its list of members. It was noted that a liaison from Council is required on the committee. Councillor Stockley expressed an interest in joining the committee.

Item: Virtual Museum Funding

In response to Councillor Stockley's inquiry, correspondence outlining the criteria to receive funding for a virtual museum was tabled. The requirements state that a full-time museum staff person is required, the provision of services to be year-round and it would have been in continuous operation for at least two years to be eligible for this funding. Based on the stipulations, it was decided not to pursue this any further.
