COMMENTARY

October marked the third consecutive monthly decline for both shares and bonds. Global equities (MSCI ACWI Index) fell -2.7% whilst Australian equities (ASX200) fell -3.8%. Emerging markets were also weaker, down -3.9% for the month. The rise in bond yields during October resulted in a -2.0% loss for Australian Bonds and a -1.2% loss for US Bonds. The broad commodity market was also weaker over the month, down -4.2%, with gold rallying 7.5% on safe haven buying but oil falling -10.1% on a weak demand outlook. The AUD fell -1.7% against the USD.

Markets were buffeted by heightened risk sentiment in October. Geopolitical risks came firmly back on the radar following the attack on Israel by Hamas on October 7th. Markets historically have moved past geopolitical incidents, albeit we are acutely aware of the escalation risks and how a wider conflict could impact energy prices, inflation and global growth. Adding to the market woes, the bond market selloff accelerated in October. Heightened supply amidst a more resilient economy continues to force investors to re-assess the right price for longer term bonds. Given real interest rates have not yet moved high enough to curtail growth significantly and bond yields historically peak at a level around the Fed funds rate, it's not hard to see how more weakness in bonds could be ahead.

The Fund was relatively well-placed heading into October, with low overall exposure to equities and bonds. We took the opportunity to sell the S&P500 exposure early in the month as the bond yield sell-off accelerated, benefitting the Fund relatively as markets fell heavily. Volatility across asset classes remain high and we continue to look for more stability as we head into the seasonally positive months ahead for risk assets.

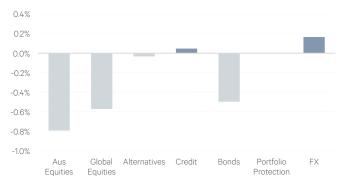
