COMMENTARY

Major equity market indices continued their year end rally in December. Global equities (MSCI ACWI Index) rose 4.1% whilst Australian equities (ASX200) rose strongly, gaining 7.3%, outperforming offshore benchmarks as small caps and real estate stocks continued their recovery. Emerging markets were the standout laggard for most of the month as China uncertainty continues. Bond markets also continued their rally, with US and Australian bonds gaining 3%. Commodities were again subdued as oil remained weak with the broad commodity index falling -3.3% while the AUD again rallied versus the USD, gaining 2.9%.

While expectations for the last Federal Reserve meeting of the year were for chairman Powell to deliver a hawkish hold, the reality was anything but. Instead, he delivered a dovish surprise via increased expected rate cuts for 2024. Markets had been bouncing in November on cooling inflation and already supportive Fed comments however what was essentially a pivot by the Fed only cemented the soft-landing narrative and continued the positive market momentum. No question uncertainty remains around the possibility of a recession in 2024, but now at least the Federal Reserve are openly looking to support growth as inflation cools, rather than risk staying too tight for too long and deliver a hard landing.

The Fund produced another positive month with returns driven by equity exposure and bonds while credit also contributed. This rounded out the year in which the Fund delivered a total return of 5.6%. While below our long-term objectives, given the broad market volatility and macro uncertainty, it's not a bad risk-adjusted result. During the month we added to global equities and global real estate in the wake of the Fed's commitment to not keep rates higher for longer whilst also reducing bonds in favour of higher yielding credit.

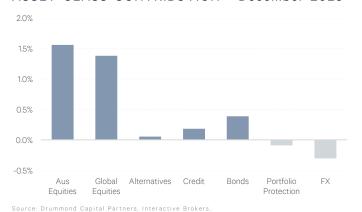

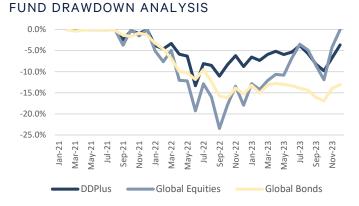
ASSET CLASS CONTRIBUTION - December 2023



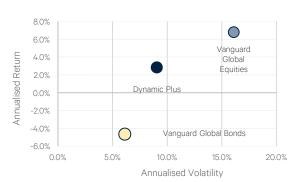

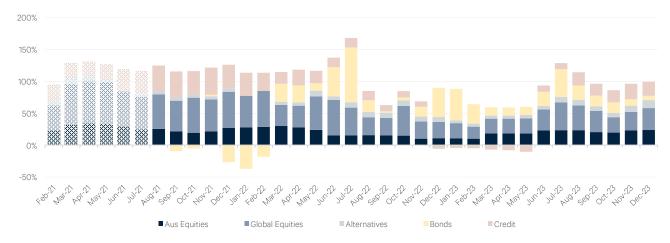


RISK REWARD COMPARISON
